FISCAL ANALYSIS

ASSUMPTION

Officials from **Department of Elementary and Secondary Education (DESE)** assume this proposal will result in an impact of \$41,840 (20 participants x 8 meeting days x \$261.50 (\$125 for hotel + \$44 for meals + \$92.50 for mileage)) for work group costs for FY 2020. DESE defers to local school districts.

Officials from the **Springfield Public Schools** assume the proposal will have no fiscal impact on their organization.

Officials from **Wellsville-Middletown R-1 School District** state public schools already have the ability to teach any religious text in a neutral manner, on a factual and historical basis.

Oversight received a limited number of responses from school districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information that we have. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight notes that two school districts stated the proposal would have no fiscal impact on their organization. Oversight does not have any information to the contrary. Also, the bill is permissive to school districts. Therefore, Oversight will reflect a zero impact on the fiscal note to local school districts.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other school districts were requested to respond to this proposed legislation but did not. FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill allows a school district to offer an elective social studies unit on the Hebrew Scriptures, the Old Testament of the Bible, or the New Testament of the Bible. The course will include the contents, history, literary style and structure, and influences on society. No requirement shall be made by the district on the text translation students must use.

By July 1, 2018, the Department of Elementary and Secondary Education (DESE) must convene a work group to develop academic performance standards for this course and before January 1, 2020 have developed written curriculum frameworks for school districts to implement.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
