FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume the proposal will result in no cost to the department.

Officials from the **Francis Howell School District** assume there would be no negative fiscal impact, as the district already maintains a supply of EpiPens.

Officials from the **Maries County R-1 School District** assume it will depend on the following factors that will likely change from year to year:

- 1) whether or not the Epi-Pens for Schools Program is still going to give free ones to schools (the last few years we were able to get 2 boxes adult and 2 boxes pediatric epi-pens for FREE, but this program limits it to two boxes of each kind per school),
- 2) the expiration date on the epi-pens received, and
- 3) availability/cost at the pharmacy at time of purchase (will generic be available?, etc.)

Right now, generic epi-pen is approximately \$260 per box and brand name is approx \$578 per box per Sinks Pharmacy in Vienna. Sinks Pharmacy stated that both types are currently unavailable and reports that availability is often an issue. Without insurance, we will be paying the high dollar cost.

Officials form the **Wellsville-Middletown R-1 School District** assume this proposal will have a marginal fiscal impact.

Oversight received a limited number of responses from school districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information that we have. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight notes that two of the responding school district stated the proposal could result in costs to the district. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a range of impact from \$0 (no additional epinephrine syringes required) to an unknown cost to maintain an adequate supply of epinephrine syringes.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill requires public schools to adopt and implement a policy beginning in the 2019-20 school year for prefilled auto syringes of epinephrine. The school nurse or designated employee of the school is responsible for the maintenance of the supply.

The State Board of Education must develop a model policy for districts to adopt before January 1, 2020.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
