## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Economic Development (Public Service Commission (PSC)** and the **Office of Public Counsel**), the **Department of Corrections**, the **Department of Public Safety - Missouri Highway Patrol**, the **Office of Prosecution Services** and the **Office of the State Public Defender** each assume the proposal will have no direct fiscal impact on their respective organizations.

Officials from PSC state that their office currently has 2 staff with security clearance to work with Missouri Information Analysis Center (MIAC) and therefore releasing records related to infrastructure security or cybersecurity to MIAC would not fiscally impact their organization.

**Oversight** notes that the agencies above have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.
