FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Higher Education** assume the proposal will have no fiscal impact on their organization.

Officials from the **University of Missouri System** assumes this proposal could have a significant financial impact on the University depending on the final language and implementation.

Officials from **State Technical College of Missouri** assume this proposal could have a significant positive fiscal impact to the College.

Officials from **Missouri State University** assume this proposal has a positive fiscal impact of an undetermined amount on the University.

Officials from **Department of Public Safety - Missouri National Guard** assume this would impact the MONG/Missouri State Tuition Assistance, but it would be an Unknown Fiscal impact to the Agency. With not knowing what the charge would be per "Program of study" we do not have the historical figures to calculate a response.

Oversight notes, based on the <u>Tuition Differential Fee Report</u> by the Board of Governors of the State University System of Florida, the tuition differential fees ranged from \$35.14 to \$52.29 per credit hour for the 2016-17 academic year for a estimated total of \$260.2 million in differential tuition revenues. Oversight assumes there could be a positive impact to colleges and universities from this proposal; however, the impact is unknown. Oversight will show a range of impact \$0 (no revenue increase) to an unknown increase in revenue that could exceed \$100,000 based on the differential rates of tuition implemented.

Oversight assumes, if institutions charge differential tuition rates, this could have an unknown impact on the tuition reimbursement scholarships and grants offered by the State such as the A+ program and the Missouri State Tuition Assistance program. Oversight assumes this would be an indirect impact and will not a show a fiscal impact.

Oversight received a limited number of responses from colleges and universities related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.
