#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could require additional resources.

Officials from the **Department of Corrections (DOC)** state in FY 2018, there was no felony or misdemeanor charge for violation of sections 115.631 and 115.637. Thus, the changes in this revision do not pose any significant fiscal impact on DOC. Therefore, DOC does not foresee any significant fiscal impact by this amendment on their agency.

Officials from the Office of Prosecution Services, Office of State Courts Administrator, and Office of the State Public Defender each assume the proposal will have no fiscal impact on their organization.

**Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Officials from St. Charles County, Platte County Board of Elections, Kansas City Election Board, and St. Louis County Board of Elections each assume the proposal will have no fiscal impact on their organization.

In response to a previous version, officials from the **Jackson County Election Board** and **Greene County** each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. **Oversight** notes that according to the Office of the State Courts Administrator, there were no convictions related to Section 115.637 in 2018.
