## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Social Services, Department of Mental Health, Department of Public Safety-Missouri State Highway Patrol, Department of Labor and Industrial Relations, and Office of State Courts Administrator** each assume the proposal will have no fiscal impact on their organization.

Officials from the **Springfield Police Department** and **Boone County Sheriff's Department** both assume the proposal will have no fiscal impact on their organization.

**Oversight** notes that the Department of Social Services, Department of Mental Health, Department of Public Safety-Missouri State Highway Patrol, Department of Labor and Industrial Relations, Office of State Courts Administrator, Department of Labor and Industrial Relations, Springfield Police Department, and Boone County Sheriff's Department have each stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other local law enforcement agencies were requested to respond to this proposed legislation but did not.
