ASSUMPTION

Officials from the **Andrew County Health Department, Osage County Health Department and Columbia/Boone County Department of Public Health and Human Services** each assume the proposal will have no fiscal impact on their organization.

In response to a previous version, officials from the **Stone County Health Department and Adair County Health Department** each assumed the proposal would have no fiscal impact on their respective organizations.

Oversight notes that the agencies mentioned above have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local public health agencies were requested to respond to this proposed legislation but did not.
