FISCAL ANALYSIS

ASSUMPTION

§§41.952, 41.953, 167.020, and 173.1155 - Military affairs

Officials from the **Department of Labor and Industrial Relations (DOLIR)** state §41.952.2 requires the DOLIR to make a notice available to all Missouri employers regarding the rights of Missouri National Guard members under this section. An Administrative Analyst II (Range 5, \$40,708) would design the poster and, once approved, make it available to employers via the department's website. The department estimates it would take 24 work hours for completion of this process. The department estimates a one-time cost of approximately \$470 ($\$40,708 / 2080 = \19.57 per hour x 24 hours) to create and make notice available to employers.

The DOLIR anticipates being able to utilize existing resources to carry out these duties.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for DOLIR.

Officials from the **State Technical College of Missouri** states his bill will have a slight negative fiscal impact.

Oversight assumes a slight negative impact can be absorbed; therefore, Oversight will reflect a zero impact in the fiscal note.

Oversight notes that the **Attorney General's Office, Department of Elementary and Secondary Education, Department of Higher Education, Department of Public Safety - (National Guard and Veterans' Commission), Office of State Courts Administrator, Missouri State University, University of Central Missouri and Francis Howell School District** have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other school districts and colleges & universities were requested to respond to this proposed legislation but did not. FISCAL IMPACT - Small Business

Small businesses will be required to extend the provisions of the Servicemembers Civil Relief Act, 50 U.S.C. 3901 et seq., and the Uniformed Services Employment and Reemployment Rights Act, 38 U.S.C. 4301, et seq., to all members of the Missouri Active Guard Reserves with thirty or more consecutive days of service and members of the Missouri National Guard who are called to active duty. They will also be required to post a notice regarding rights of Missouri National Guard members.

Small businesses would also be required to allow for cancellation of contracts for services for National Guard and Reserves members who are ordered to a temporary location for more than thirty consecutive days or called to active duty.

FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
