# ASSUMPTION

Officials at the **Office of the State Courts Administrator** assume there may be some impact but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

Officials at the **Department of Elementary and Secondary Education** assume no fiscal impact from this proposal.

In response to a previous version, officials at the **Department of Social Services** assumed no fiscal impact from this proposal.

**Oversight** notes that the Office of the State Courts Administrator, the Department of Elementary and Secondary Education and the Department of Social Services each has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials at the **Wellsville-Middletown R-1 School District** assume no fiscal impact from this proposal.

In response to a previous version, officials at the **Francis Howell School District**, the **Sherwood Cass R-VIII School District** and the **Centralia R-VI Schools** each assumed no fiscal impact to their respective entities from this proposal.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other schools were requested to respond to this proposed legislation but did not.
