FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume the proposal will result in no cost to their organization.

Officials from the **Department of Higher Education** assume the proposal will have no fiscal impact on their organization.

Officials from **Lee's Summit R-7 School District** assume this proposal would result in a fiscal impact of less than \$100,000.

Officials from the **Missouri State University** assume the proposal will have no fiscal impact on their organization.

In response to a previous version, HB 743 (2019), officials from the Wellsville-Middletown R-1 School District, Francis Howell School District, University of Central Missouri and State Technical College of Missouri each assume the proposal will have no fiscal impact on their organization.

In response to a previous version, HB 743 (2019), officials from **Lewis County C-1 Schools** state that there would be an undisclosed increase in legal fees associated with this proposal.

In response to a similar proposal, HB 1940 (2018), officials from the **Kirksville R-III School District**, **West Plains School District** and **Missouri Western State University** each assumed the proposal would have no fiscal impact on their organization.

Oversight notes that the most of responding organizations stated the proposal would not have a direct fiscal impact on their organization. Oversight assumes that any increase in legal fees could be absorbed with existing resources. Oversight assumes the proposal will result in no fiscal impact.
