## FISCAL ANALYSIS

### ASSUMPTION

#### Section 190.205

Officials from the **Department of Health and Senior Services** assume the proposed legislation states that an air ambulance provider or agent shall not solicit or sell subscription agreements relating to the services or billing provided. The Division of Regulation and Licensure (DRL) is responsible for licensing and conducting inspections of air ambulance services. Revising regulations and review of air ambulance service records are within the normal ebb and flow of work for DRL so minimal time and expense will be required to conduct the requirements of the proposed legislation.

The department anticipates being able to absorb these costs. However, until the FY20 budget is final, the department cannot identify specific funding sources.

**Oversight** notes that the DRL has stated the cost related to the proposal could be absorbed. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Department of Insurance, Financial Institutions and Professional Registration**, the **Department of Social Services**, the **Missouri Consolidated Health Care Plan**, the **Missouri Department of Conservation** and the **Department of Transportation** each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Department of Public Safety** - **Missouri Highway Patrol** defer to the Department of Transportation to estimate the fiscal impact of the proposed legislation on their respective organization.
