FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could require additional resources.

Officials from the **Joint Committee on Administrative Rules (JCAR)** state this legislation is not anticipated to cause a fiscal impact beyond its current appropriation.

Oversight assumes JCAR will be able to administer any rules resulting from this proposal with existing resources.

Officials from the **Department of Economic Development** assume due to the infrequency of emergency rules processed, it is not expected there would be any additional annual cost. The PSC expects to be able to process any emergency rules with existing staff and appropriation authority.

Highway Patrol, Office of the Governor, Office of State Courts Administrator, Missouri House of Representatives, Office of Administration-Administrative Hearing Commission, MoDOT and Patrol Employees Retirement System, Department of Natural Resources, Department of Health and Senior Services, Department of Higher Education, Office of Administration, Department of Public Safety-Capitol Police, Office of Prosecution Services, Department of Public Safety-Alcohol and Tobacco Control, Department of Public Safety-State Emergency Management Agency, Missouri Senate, Missouri Tax Commission, Missouri Consolidated Health Care Plan, Missouri Lottery Commission, Office of the State Public Defender, Missouri State Employees' Retirement System, Department of Revenue, Legislative Research, and Department of Public Safety-Fire Safety each assume the proposal will have no fiscal impact on their organization.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.
