Oversight notes that the Department of Public Safety - Missouri State Highway Patrol, Office of Secretary of State, Joplin Police Department and St. Louis County Department of Justice Services have each stated the proposal would not have a direct fiscal impact on their respective organizations.

In response to a previous version (HB 968), officials from the **Attorney General's Office**, **Springfield Police Department** and **St. Louis County Police Department** stated the proposal would not have a direct fiscal impact on their organizations.
