FISCAL ANALYSIS

ASSUMPTION

Oversight notes that the **Department of Health and Senior Services** and the **Department of Social Services** have each stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these organizations.

Oversight notes the provisions of this proposal provide that social model end of life care homes shall be funded through donations and grants and shall not accept Medicare, Medicaid, or insurance payments. The provisions of Sections 198.003 to 198.189 (intermediate care and skilled nursing facilities, assisted living facilities or residential care facilities) do not apply to any provider of social model end of life care home as defined by this proposal.
