FISCAL ANALYSIS

ASSUMPTION

Officials from the **Springfield Police Department**, **Joplin Police Department**, **St. Louis County Department of Justice Services** and **St. Louis County Police Department** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Wellsville-Middletown R-1 School District** and **Springfield Public Schools** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Sherwood Cass R-VIII School District** assume this would be no cost to us as a school district if the procedure was to come with documentation already with permission from law enforcement. Otherwise it could take us time to contact law enforcement, have them do a check, and get back with us.

Oversight received a limited number of responses from local political subdivisions related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight notes that the responding organizations have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other school districts and local law enforcement agencies were requested to respond to this proposed legislation but did not.
