ASSUMPTION

Officials from the **Springfield Police Department**, **Joplin Police Department**, **St. Louis County Department of Justice Services** each assume the proposal will have no fiscal impact on their organization.

Oversight received a limited number of responses from local political subdivisions related to the fiscal impact of this proposal.
