ASSUMPTION

In response to a previous version, officials from the **Department of Economic Development** (**Division of Energy**, **Public Service Commission**, **Office of Public Counsel**), the **Attorney General's Office** and the **Metropolitan St. Louis Sewer District** each assumed the proposal would have no fiscal impact on their respective organizations.

Officials from the **Department of Natural Resources** assume the proposal will have no fiscal impact on their organization.

Oversight notes that the above mentioned agencies have each stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other utilities were requested to respond to this proposed legislation but did not.
