FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the Secretary of State (SOS)** assume a number of joint resolutions that would refer to a vote of the people a constitutional amendment and bills that would refer to a vote of the people the statutory issue in the legislation may be considered by the General Assembly.

Unless a special election is called for the purpose, Joint Resolutions proposing a constitutional amendment are submitted to a vote of the people at the next general election. Article XII section 2(b) of the Missouri Constitution authorizes the governor to order a special election for constitutional amendments referred to the people. If a special election is called to submit a Joint Resolution to a vote of the people, section 115.063.2 RSMo requires the state to pay the costs. The cost of the special election has been estimated to be \$7.8 million based on the cost of the 2016 Presidential Preference Primary.

The SOS is required to pay for publishing in local newspapers the full text of each statewide ballot measure as directed by Article XII, Section 2(b) of the Missouri Constitution and Section 116.230-116.290, RSMo. Funding for this item is adjusted each year depending upon the election cycle. A new decision item is requested in odd numbered fiscal years and the amount requested is dependent upon the estimated number of ballot measures that will be approved by the General Assembly and the initiative petitions certified for the ballot. In FY 2014, the General Assembly changed the appropriation so that it was no longer an estimated appropriation.

In FY19, over \$5.8 million was spent to publish the full text of the measures for the August and November elections. The SOS estimates \$65,000 per page for the costs of publications based on the actual cost incurred for the one referendum that was on the August 2018 ballot.

The SOS will continue to assume, for the purposes of this fiscal note, that it should have the full appropriation authority it needs to meet the publishing requirements. Because these requirements are mandatory, we reserve the right to request funding to meet the cost of our publishing requirements if the Governor and the General Assembly again change the amount or continue to not designate it as an estimated appropriation.

Oversight has reflected in this fiscal note, the state potentially reimbursing local political subdivisions the cost of having this joint resolution voted on during a special election in fiscal year 2020. This reflects the decision made by the Joint Committee on Legislative Research, that the cost of the elections should be shown in the fiscal note. The next scheduled statewide primary election is in August 2020 and the next scheduled general election is in November 2020

(both in FY 2021). It is assumed the subject within this proposal could be on one of these ballots; however, it could also be on a special election called for by the Governor. Therefore, Oversight will reflect a potential election cost reimbursement to local political subdivisions in FY 2020.

Officials at **St. Louis County** assume if the election is held in November 2020 (first option listed in the resolution), there would be no cost for this general election.

If the other option specified in the bill is chosen, which is a special election called by the Governor for that purpose, then the cost of a stand-alone special election would be \$1 million according to the St. Louis County Board of Elections.

The third option, which is not specified in the bill, would be the assignment of this issue to a municipal election in April, in which case the Board of Elections estimates a \$350,000 cost.

Officials at the **City of St. Louis** assume the proposed constitutional amendment addresses only the manner in which any proposed merger of City and County is to be approved rather than the substance of any proposed merger. The City of St. Louis assumes no impact from this proposal.

Officials at the **St. Louis County Board of Election Commissioners** and the **Platte County Board of Election Commissioners** each assume no fiscal impact to their respective entities from this proposal.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

Upon voter approval, this proposed Constitutional amendment would require a majority vote in order to create a new political subdivision within a county or city not within a county where the vote must be held in both the proposed new political subdivision territory and the existing county or city not within a county in order to authorize the new political subdivision. The amendment also prohibits ballot measures to dissolve any city or county or merge any city or county with another city or county unless there is a majority vote in each affected city or county authorizing the dissolution or merger.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
