#### FISCAL ANALYSIS

#### ASSUMPTION

Officials from the **Department of Economic Development (Division of Energy, Public Service Commission (PSC), Office of Public Counsel)** and the **Attorney General's Office** each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** requested additional information from the PSC regarding the intent and impact of the legislation. **PSC** stated the impact of HB 1138 is uncertain due to a number of factors. PSC suggested some definitions and clarifying language be included in future versions of the bill.

PSC stated if definitions and language clarifications were included, HB 1138's impact to customers would vary depending on the utility's rate structure and profile of its customer base. The impact would be unknown until the utility's subsequent general rate case where the PSC would have the opportunity to look at how qualifying customers who participated in HB 1138's structure impacted revenues, energy usage, and other aspects significant to the "all relevant factors" analysis the PSC uses in general rate cases.

Due to the uncertainty of the proposal, **Oversight** will reflect a range from \$0 to an unknown cost to the state, colleges and universities as well as local political subdivisions **if** utility rates are adversely impacted.

### FISCAL DESCRIPTION

This bill specifies that electric energy may be provided and obtained on a wholesale basis at any electric generating facility over a transformation and transmission interconnect under applicable federal tariffs of a regional transmission organization instead of under retail service tariffs filed with the Public Service Commission.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
