FISCAL ANALYSIS

ASSUMPTION

Officials from the **Missouri Ethics Commission (MEC)** assume the proposed legislation does not have a fiscal impact on the MEC. However, if the Commission identifies significant violations during the process established in Section 105.955.14 (2), (3), RSMo or complaints received increase significantly additional staff would be required to provide the proper oversight.

Officials from the **Joint Committee on Administrative Rules (JCAR)** state this legislation is not anticipated to cause a fiscal impact beyond its current appropriation.

Oversight assumes JCAR will be able to administer any rules resulting from this proposal with existing resources.

Officials from the Department of Social Services, Attorney General's Office, Missouri Department of Conservation, Office of the Secretary of State, Office of State Courts Administrator, Department of Corrections, Department of Labor and Industrial Relations, State Auditor's Office, Department of Transportation, Department of Natural Resources, Department of Mental Health, Missouri State Employees' Retirement System, Department of Public Safety-Missouri State Highway Patrol, Department of Insurance, Financial Institutions and Professional Registration, Department of Economic Development, Office of the State Treasurer, Department of Elementary and Secondary Education, Office of Administration-Administrative Hearing Commission, Department of Public Safety-Missouri National Guard, Office of Administration-Budget and Planning, Department of Public Safety-Office of the Director, Missouri House of Representatives, Missouri Tax Commission, Department of Health and Senior Services, Office of Administration, Office of the Governor, Department of Public Safety-Capitol Police, Department of Public Safety-Division of Alcohol and Tobacco Control, Department of Higher Education, Department of Revenue, Department of Public Safety-Gaming Commission, Office of the State Public Defender, MoDOT and Patrol Employees Retirement System, Missouri Senate, Legislative Research, Department of Public Safety-Fire Safety, Department of Public Safety-State Emergency Management Agency, Missouri Lottery Commission, Missouri Consolidated Health Care Plan, and Office of Prosecution Services each assume the proposal will have no fiscal impact on their organization.
