AN ACT

Relating to the "National Day of the Cowboy."

Be it enacted by the General Assembly of the state of Missouri, as follows:

2 **WHEREAS**, Missouri's pioneering men and women, known as cowboys, helped
3 establish America's frontier; and

4 **WHEREAS**, the first large-scale effort to drive cattle from Texas to the nearest railhead
5 for shipment to Chicago occurred in 1866, when many Texas ranchers banded together to drive
6 their cattle to the closest point that railroad tracks reached, which at that time was Sedalia,
7 Missouri, now known as the Trail's End in Sedalia, Missouri; and

9 **WHEREAS**, the Kansas City Stockyards were established in 1871 in the West Bottoms,
10 west of downtown Kansas City, and flourished until closing in 1991. The stockyards were built
11 around the facilities of the Central Overland California and Pike's Peak Express Company, which
12 had outfitted travelers on the Santa Fe Trail and Oregon Trail following the Kansas River. The
13 company went out of business in 1862 following the failure of its Pony Express business from
14 St. Joseph, Missouri, to Sacramento, California; and

15
16 **WHEREAS**, the stockyards and Hereford breeders began the American Royal Livestock
17 and Horse Show in October of 1899 as the National Hereford Show, the first nationwide show
18 for the exposition and sale of purebred cattle. In 1907 the first American Royal Horse Show was
19 added and now includes five different shows, known as the Quarter Horse Show, the
20 Hunter-Jumper Horse Show, the Arabian Horse Show, the Youth Horse Show, and the Cutting
21 Horse Show. The American Royal is an annual eight-week season of barbecue competition,
22 rodeos, livestock shows, equestrian events, and agricultural activities benefitting youth and
23 education; and

25 **WHEREAS**, in 1926, the American Royal began inviting vocational agriculture students
26 to judge the livestock shows. During the 1928 American Royal, 33 of the students meeting at the
27 Baltimore Hotel in downtown Kansas City formed the Future Farmers of America. Now, the
28 National FFA Organization has 579,678 members; and

30 **WHEREAS**, the cowboy archetype transcends gender, generations, ethnicity, geographic
31 boundaries, and political affiliations; and

32

33 **WHEREAS**, the cowboy embodies honesty, integrity, courage, compassion, and
34 determination; and

35

36 **WHEREAS**, the cowboy vaquero spirit exemplifies patriotism and strength of character
37 and is an excellent steward of the land and its creatures; and

38

39 **WHEREAS**, the core values expressed within the Cowboy Code of Conduct continue
40 to inspire the pursuit of the highest caliber of personal integrity; and

42 **WHEREAS**, cowboy and ranching traditions have been part of the American landscape
43 and culture since 1523, and today's cowboys continue to strive to preserve and perpetuate this
44 unique element of America's heritage; and

45

46 **WHEREAS**, membership and participation in the National Day of the Cowboy
47 Organization and other organizations that encompass the livelihood of the cowboy continue to
48 expand both nationally and internationally; and

49

50 **WHEREAS**, the cowboy and his horse are a central figure in literature, art, film, poetry,
51 photography, and music; and

52

53 **WHEREAS**, the cowboy is a true American icon occupying a central place in the public's
54 imagination;

56 **NOW THEREFORE BE IT RESOLVED** that the members of the House of
57 Representatives of the One Hundredth General Assembly, First Regular Session, the Senate
58 concurring therein, hereby designate the fourth Saturday in July each year as "National Day of
59 the Cowboy" in Missouri; and

61 **BE IT FURTHER RESOLVED** that the General Assembly recommends to the citizens
62 to observe the day with appropriate ceremonies and activities; and

64 **BE IT FURTHER RESOLVED** that this resolution be sent to the Governor for his
65 approval or rejection pursuant to the Missouri Constitution.
