AN ACT

To amend chapter 143, RSMo, by adding thereto one new section relating to a tax refund donation.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 143, RSMo, is amended by adding thereto one new section, to be 2 known as section 143.1028, to read as follows:

3 143.1028. 1. For all tax years beginning on or after January 1, 2019, and ending before January 1, 2024, each individual or corporation entitled to a tax refund in an 4 amount sufficient to make a designation under this section may designate that one dollar 5 or any amount in excess of one dollar on a single return, or two dollars or any amount in 6 excess of two dollars on a combined return, of the refund due be credited to the Kansas 7 City Regional Law Enforcement Memorial Foundation Fund, hereinafter referred to as 8 the fund. The contribution designation authorized by this section shall be clearly and 9 10 unambiguously printed on the first page of each income tax return form provided by this state. If any individual or corporation that is not entitled to a tax refund in an amount 11 12 sufficient to make a designation under this section wishes to make a contribution to the 13 foundation, such individual or corporation may, by separate check, draft, or other 14 negotiable instrument, send in with the payment of taxes, or may send in separately, that 15 amount the individual wishes to contribute. Such amounts shall be clearly designated for 16 the fund. 17 2. There is hereby created in the state treasury the "Kansas City Regional Law

18 Enforcement Memorial Foundation Fund", which shall consist of moneys collected under

19 this section. The state treasurer shall be custodian of the fund. In accordance with sections

20 30.170 and 30.180, the state treasurer may approve disbursements. The fund shall be a dedicated fund and, upon appropriation, moneys in this fund shall be used solely for the 21 22 administration of this section. Notwithstanding the provisions of section 33.080 to the 23 contrary, any moneys remaining in the fund at the end of the biennium shall not revert to 24 the credit of the general revenue fund. The state treasurer shall invest moneys in the fund in the same manner as other funds are invested. Any interest and moneys earned on such 25 26 investments shall be credited to the fund. The state treasurer shall distribute all moneys 27 deposited in the fund at least monthly to the Kansas City Regional Law Enforcement 28 **Memorial Foundation.**

3. The director of revenue shall deposit at least monthly all contributions designated by individuals and corporations under this section, less an amount sufficient to cover the costs of collection and handling by the department of revenue, to the state treasurer for deposit to the fund. A contribution designated under this section shall only be deposited in the fund after all other claims against the refund from which such contribution is to be made have been satisfied.
