## **AN ACT**

To amend chapter 227, RSMo, by adding thereto five new sections relating to the designation of Purple Heart Trails.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 227, RSMo, is amended by adding thereto five new sections, to be known as sections 227.463, 227.464, 227.465, 227.466, and 227.467, to read as follows:

 $227.463.\ The\ portion\ of\ Interstate\ 29\ from\ its\ intersection\ of\ Interstate\ 70/U.S.\ State$ 

- 2 Highway 71/40 in Jackson County north to the bridge crossing over Nishnabotna River in
- 3 Atchison County, except for those portions of Interstate 29 previously designated as of
- 4 August 28, 2019, shall be designated the "Purple Heart Trail". Costs for such designation
- 5 shall be paid by private donations.
  - 227.464. The portion of Interstate 35 from city of Kansas City in Jackson County
- 2 north to U.S. State Highway 69 in Harrison County, except for those portions of Interstate
- 3 35 previously designated as of August 28, 2019, shall be designated the "Purple Heart
- 4 Trail". Costs for such designation shall be paid by private donations.
  - 227.465. The portion of Interstate 55 from its intersection of Interstate 70/U.S. State
- 2 Highway 71/40 in Jackson County north to the bridge crossing over Nishnabotna River in
- 3 Atchison County, except for those portions of Interstate 29 previously designated as of
- 4 August 28, 2019, shall be designated the "Purple Heart Trail". Costs for such designation
- 5 shall be paid by private donations.
- 227.466. The portion of Interstate 57 from the Missouri/Illinois state line in
- 2 Mississippi County continuing south to U.S. State Highway 60/State Highway AA in Scott
