- 105.470. As used in section 105.473, unless the context requires otherwise, the following words and terms mean:
- 8 (1) "Elected local government official lobbyist", any
 9 natural person employed specifically for the purpose of
 10 attempting to influence any action by a local government official
 11 elected in a county, city, town, or village with an annual
- 13 (2) "Executive lobbyist", any natural person who acts for
 14 the purpose of attempting to influence any action by the
 15 executive branch of government or by any elected or appointed
 16 official, employee, department, division, agency or board or
 17 commission thereof and in connection with such activity, meets
 18 the requirements of any one or more of the following:
 - (a) Is acting in the ordinary course of employment on behalf of or for the benefit of such person's employer; or
 - (b) Is engaged for pay or for any valuable consideration for the purpose of performing such activity; or
 - (c) Is designated to act as a lobbyist by any person, business entity, governmental entity, religious organization, nonprofit corporation, association or other entity; or
 - (d) Makes total expenditures of fifty dollars or more during the twelve-month period beginning January first and ending

- 1 December thirty-first for the benefit of one or more public
- 2 officials or one or more employees of the executive branch of
- 3 state government in connection with such activity.
- 4 An "executive lobbyist" shall not include a member of the general
- 5 assembly, an elected state official, or any other person solely
- 6 due to such person's participation in any of the following
- 7 activities:
- 8 a. Appearing or inquiring in regard to a complaint,
- 9 citation, summons, adversary proceeding, or contested case before
- 10 a state board, commission, department, division or agency of the
- 11 executive branch of government or any elected or appointed
- 12 officer or employee thereof;
- b. Preparing, filing or inquiring, or responding to any
- 14 audit, regarding any tax return, any public document, permit or

- g. Acting within the scope of employment by the general assembly, or acting within the scope of employment by the executive branch of government when acting with respect to the department, division, board, commission, agency or elected state officer by which such person is employed, or with respect to any duty or authority imposed by law to perform any action in conjunction with any other public official or state employee; or
 - h. Testifying as a witness before a state board, commission or agency of the executive branch;
 - (3) "Expenditure", any payment made or charge, expense, cost, debt or bill incurred; any gift, honorarium or item of value bestowed including any food or beverage; any price, charge or fee which is waived, forgiven, reduced or indefinitely delayed; any loan or debt which is cancelled, reduced or otherwise forgiven; the transfer of any item with a reasonably discernible cost or fair market value from one person to another or provision of any service or granting of any opportunity for which a charge is customarily made, without charge or for a reduced charge; except that the term "expenditure" shall not include the following:
 - (a) Any item, service or thing of value transferred to any person within the third degree of consanguinity of the transferor which is unrelated to any activity of the transferor as a lobbyist;
 - (b) Informational material such as books, reports,

- pamphlets, calendars or periodicals informing a public official regarding such person's official duties, or souvenirs or mementos valued at less than ten dollars;
 - (c) Contributions to the public official's campaign committee or candidate committee which are reported pursuant to the provisions of chapter 130;

- (d) Any loan made or other credit accommodations granted or other payments made by any person or entity which extends credit or makes loan accommodations or such payments in the regular ordinary scope and course of business, provided that such are extended, made or granted in the ordinary course of such person's or entity's business to persons who are not public officials;
- (e) Any item, service or thing of de minimis value offered to the general public, whether or not the recipient is a public official or a staff member, employee, spouse or dependent child of a public official, and only if the grant of the item, service or thing of de minimis value is not motivated in any way by the recipient's status as a public official or staff member, employee, spouse or dependent child of a public official;
- (f) The transfer of any item, provision of any service or granting of any opportunity with a reasonably discernible cost or fair market value when such item, service or opportunity is necessary for a public official or employee to perform his or her duty in his or her official capacity, including but not limited to entrance fees to any sporting event, museum, or other venue when the official or employee is participating in a ceremony, public presentation or official meeting therein;

1 (g) Any payment, gift, compensation, fee, expenditure or
2 anything of value which is bestowed upon or given to any public
3 official or a staff member, employee, spouse or dependent child
4 of a public official when it is compensation for employment or
5 given as an employment benefit and when such employment is in
6 addition to their employment as a public official;

- (4) "Judicial lobbyist", any natural person who acts for the purpose of attempting to influence any purchasing decision by the judicial branch of government or by any elected or appointed official or any employee thereof and in connection with such activity, meets the requirements of any one or more of the following:
- (a) Is acting in the ordinary course of employment which primary purpose is to influence the judiciary in its purchasing decisions on a regular basis on behalf of or for the benefit of such person's employer, except that this shall not apply to any person who engages in lobbying on an occasional basis only and not as a regular pattern of conduct; or
- (b) Is engaged for pay or for any valuable consideration for the purpose of performing such activity; or
 - (c) Is designated to act as a lobbyist by any person, business entity, governmental entity, religious organization, nonprofit corporation or association; or
 - (d) Makes total expenditures of fifty dollars or more during the twelve-month period beginning January first and ending December thirty-first for the benefit of one or more public officials or one or more employees of the judicial branch of

- 1 state government in connection with attempting to influence such
- 2 purchasing decisions by the judiciary.
- 3 A "judicial lobbyist" shall not include a member of the general
- 4 assembly, an elected state official, or any other person solely
- 5 due to such person's participation in any of the following
- 6 activities:
- 7 a. Appearing or inquiring in regard to a complaint,
- 8 citation, summons, adversary proceeding, or contested case before
- 9 a state court;
- 10 b. Participating in public hearings or public proceedings
- on rules, grants, or other matters;
- 12 c. Responding to any request for information made by any
- judge or employee of the judicial branch of government;
- d. Preparing, distributing or publication of an editorial,
- 15 a newsletter, newspaper, magazine, radio or television broadcast,
- or similar news medium, whether print or electronic; or
- 17 e. Acting within the scope of employment by the general
- assembly, or acting within the scope of employment by the
- 19 executive branch of government when acting with respect to the
- department, division, board, commission, agency or elected state
- officer by which such person is employed, or with respect to any
- 22 duty or authority imposed by law to perform any action in
- 23 conjunction with any other public official or state employee;
- 24 (5) "Legislative lobbyist", any natural person who acts for
- 25 the purpose of attempting to influence the taking, passage,
- amendment, delay or defeat of any official action on any bill,
- 27 resolution, amendment, nomination, appointment, report or any

- 1 other action or any other matter pending or proposed in a
- 2 legislative committee in either house of the general assembly, or
- 3 in any matter which may be the subject of action by the general
- 4 assembly and in connection with such activity, meets the
- 5 requirements of any one or more of the following:
- 6 (a) Is acting in the ordinary course of employment, which
- 7 primary purpose is to influence legislation on a regular basis,
- 8 on behalf of or for the benefit of such person's employer, except
- 9 that this shall not apply to any person who engages in lobbying
- on an occasional basis only and not as a regular pattern of
- 11 conduct; or
- 12 (b) Is engaged for pay or for any valuable consideration
- for the purpose of performing such activity; or
- 14 (c) Is designated to act as a lobbyist by any person,
- business entity, governmental entity, religious organization,
- 16 nonprofit corporation, association or other entity; or
- 17 (d) Makes total expenditures of fifty dollars or more
- during the twelve-month period beginning January first and ending
- 19 December thirty-first for the benefit of one or more public
- officials or one or more employees of the legislative branch of
- 21 state government in connection with such activity.
- 22 A "legislative lobbyist" shall include an attorney at law engaged
- in activities on behalf of any person unless excluded by any of
- 24 the following exceptions. A "legislative lobbyist" shall not
- 25 include any legislative liaison. For purposes of this
- 26 <u>subdivision</u>, "legislative liaison" means any state employee hired
- 27 <u>to communicate with members of the general assembly on behalf of</u>

- 1 any elected official of the state; the judicial branch of state
- 2 government; or any department, agency, board, or commission of
- 3 the state, provided such entity is a part of the executive branch
- 4 <u>of state government. Any state employee employed as a</u>
- 5 <u>legislative liaison who performs lobbying services for any other</u>
- 6 entity shall register as a lobbyist with respect to such lobbying
- 7 <u>services.</u> A "legislative lobbyist" shall <u>also</u> not include any
- 8 member of the general assembly, an elected state official, or any
- 9 other person solely due to such person's participation in any of
- 10 the following activities:
- 11 a. Responding to any request for information made by any
- 12 public official or employee of the legislative branch of
- 13 government;
- b. Preparing or publication of an editorial, a newsletter,
- 15 newspaper, magazine, radio or television broadcast, or similar
- 16 news medium, whether print or electronic;
- 17 c. Acting within the scope of employment of the legislative
- branch of government when acting with respect to the general
- 19 assembly or any member thereof;
- d. Testifying as a witness before the general assembly or
- 21 any committee thereof;
- 22 (6) "Lobbyist", any natural person defined as an executive
- lobbyist, judicial lobbyist, elected local government official
- 24 lobbyist, or a legislative lobbyist;
- 25 (7) "Lobbyist principal", any person, business entity,
- 26 governmental entity, religious organization, nonprofit
- 27 corporation or association who employs, contracts for pay or

- 1 otherwise compensates a lobbyist;
- 2 (8) "Public official", any member or member-elect of the
- 3 general assembly, judge or judicial officer, or any other person
- 4 holding an elective office of state government or any agency
- 5 head, department director or division director of state
- 6 government or any member of any state board or commission and any
- 7 designated decision-making public servant designated by persons
- 8 described in this subdivision.
- 9 190.094. 1. Any ambulance licensed in this state, when
- 10 used as an ambulance and staffed with volunteer staff, shall be
- 11 staffed with a minimum of one emergency medical technician and
- one other crew member who may be a licensed emergency medical
- 13 technician, registered nurse, physician assistant, assistant

 3 person who has successfully completed a course of instruction in
 4 certain aspects of advanced life support care as prescribed by
 5 the department and is licensed by the department in accordance
 6 with sections 190.001 to 190.245 and rules and regulations
 7 adopted by the department pursuant to sections 190.001 to
 8 190.245;
 - (2) "Advanced life support (ALS)", an advanced level of care as provided to the adult and pediatric patient such as defined by national curricula, and any modifications to that curricula specified in rules adopted by the department pursuant to sections 190.001 to 190.245;
 - craft that is specially designed, constructed or modified, staffed or equipped for, and is intended or used, maintained or operated for the transportation of persons who are sick, injured, wounded or otherwise incapacitated or helpless, or who require the presence of medical equipment being used on such individuals, but the term does not include any motor vehicle specially designed, constructed or converted for the regular transportation of persons who are disabled, handicapped, normally using a wheelchair, or otherwise not acutely ill, or emergency vehicles used within airports;
 - (4) "Ambulance service", a person or entity that provides emergency or nonemergency ambulance transportation and services, or both, in compliance with sections 190.001 to 190.245, and the

- 1 rules promulgated by the department pursuant to sections 190.001
- 2 to 190.245;
- 3 (5) "Ambulance service area", a specific geographic area in
- 4 which an ambulance service has been authorized to operate;
- 5 (6) "Basic life support (BLS)", a basic level of care, as
- 6 provided to the adult and pediatric patient as defined by
- 7 national curricula, and any modifications to that curricula
- 8 specified in rules adopted by the department pursuant to sections
- 9 190.001 to 190.245;
- 10 "Council", the state advisory council on emergency
- 11 medical services;
- 12 (8) "Department", the department of health and senior
- 13 services, state of Missouri;
- 14 (9) "Director", the director of the department of health
- and senior services or the director's duly authorized
- 16 representative;
- 17 (10) "Dispatch agency", any person or organization that
- 18 receives requests for emergency medical services from the public,
- by telephone or other means, and is responsible for dispatching
- 20 emergency medical services;
- 21 (11) "Emergency", the sudden and, at the time, unexpected
- 22 onset of a health condition that manifests itself by symptoms of
- 23 sufficient severity that would lead a prudent layperson,
- 24 possessing an average knowledge of health and medicine, to
- 25 believe that the absence of immediate medical care could result
- 26 in:
- 27 (a) Placing the person's health, or with respect to a

- 1 pregnant woman, the health of the woman or her unborn child, in
- 2 significant jeopardy;
- 3 (b) Serious impairment to a bodily function;
- (c) Serious dysfunction of any bodily organ or part;
- 5 (d) Inadequately controlled pain;
- 6 (12) "Emergency medical dispatcher", a person who receives
- 7 emergency calls from the public and has successfully completed an
- 8 emergency medical dispatcher course, meeting or exceeding the
- 9 national curriculum of the United States Department of
- 10 Transportation and any modifications to such curricula specified
- 11 by the department through rules adopted pursuant to sections
- 12 190.001 to 190.245;
- 13 "Emergency medical responder", a person who has
- 14 successfully completed an emergency first response course meeting
- or exceeding the national curriculum of the U.S. Department of
- 16 Transportation and any modifications to such curricula specified
- 17 by the department through rules adopted under sections 190.001 to
- 18 190.245 and who provides emergency medical care through
- 19 employment by or in association with an emergency medical
- 20 response agency;
- 21 (14) "Emergency medical response agency", any person that
- 22 regularly provides a level of care that includes first response,
- 23 basic life support or advanced life support, exclusive of patient
- 24 transportation;
- 25 (15) "Emergency medical services for children (EMS-C)
- 26 system", the arrangement of personnel, facilities and equipment
- 27 for effective and coordinated delivery of pediatric emergency

- 1 medical services required in prevention and management of
- 2 incidents which occur as a result of a medical emergency or of an
- 3 injury event, natural disaster or similar situation;
- 4 (16) "Emergency medical services (EMS) system", the
- 5 arrangement of personnel, facilities and equipment for the
- 6 effective and coordinated delivery of emergency medical services
- 7 required in prevention and management of incidents occurring as a
- 8 result of an illness, injury, natural disaster or similar
- 9 situation;
- 10 "Emergency medical technician", a person licensed in
- 11 emergency medical care in accordance with standards prescribed by
- sections 190.001 to 190.245, and by rules adopted by the
- department pursuant to sections 190.001 to 190.245;
- 14 (18) "Emergency medical technician-basic" or "EMT-B", a
- person who has successfully completed a course of instruction in
- 16 basic life support as prescribed by the department and is
- 17 licensed by the department in accordance with standards
- prescribed by sections 190.001 to 190.245 and rules adopted by
- the department pursuant to sections 190.001 to 190.245;
- 20 (19) "Emergency medical technician-community paramedic",
- "community paramedic", or "EMT-CP", a person who is certified as
- 22 an emergency medical technician-paramedic and is certified by the
- 23 department in accordance with standards prescribed in section
- 24 190.098;
- 25 (20) "Emergency medical technician-paramedic" or "EMT-P", a
- 26 person who has successfully completed a course of instruction in
- 27 advanced life support care as prescribed by the department and is

- licensed by the department in accordance with sections 190.001 to
- 2 190.245 and rules adopted by the department pursuant to sections
- 3 190.001 to 190.245;
- 4 (21) "Emergency services", health care items and services
- 5 furnished or required to screen and stabilize an emergency which
- 6 may include, but shall not be limited to, health care services
- 7 that are provided in a licensed hospital's emergency facility by
- 8 an appropriate provider or by an ambulance service or emergency
- 9 medical response agency;
- 10 (22) "Health care facility", a hospital, nursing home,
- 11 physician's office or other fixed location at which medical and
- 12 health care services are performed;
- 13 (23) "Hospital", an establishment as defined in the
- 14 hospital licensing law, subsection 2 of section 197.020, or a
- 15 hospital operated by the state;
- 16 (24) "Medical control", supervision provided by or under
- 17 the direction of physicians, or their designated registered
- 18 nurse, including both online medical control, instructions by
- 19 radio, telephone, or other means of direct communications, and
- offline medical control through supervision by treatment
- 21 protocols, case review, training, and standing orders for
- 22 treatment;
- 23 (25) "Medical direction", medical guidance and supervision
- 24 provided by a physician to an emergency services provider or
- 25 emergency medical services system;
- 26 (26) "Medical director", a physician licensed pursuant to
- 27 chapter 334 designated by the ambulance service or emergency

1 medical response agency and who meets criteria specified by the 2 department by rules pursuant to sections 190.001 to 190.245;

- (27) "Memorandum of understanding", an agreement between an emergency medical response agency or dispatch agency and an ambulance service or services within whose territory the agency operates, in order to coordinate emergency medical services;
- (28) "Patient", an individual who is sick, injured, wounded, diseased, or otherwise incapacitated or helpless, or dead, excluding deceased individuals being transported from or between private or public institutions, homes or cemeteries, and individuals declared dead prior to the time an ambulance is called for assistance;
- "Person", as used in these definitions and elsewhere 13 14 in sections 190.001 to 190.245, any individual, firm, partnership, copartnership, joint venture, association, 15 cooperative organization, corporation, municipal or private, and 16 17 whether organized for profit or not, state, county, political 18 subdivision, state department, commission, board, bureau or fraternal organization, estate, public trust, business or common 19 law trust, receiver, assignee for the benefit of creditors, 20 trustee or trustee in bankruptcy, or any other service user or 21 22 provider;
- 23 (30) "Physician", a person licensed as a physician pursuant 24 to chapter 334;
 - (31) "Political subdivision", any municipality, city, county, city not within a county, ambulance district or fire protection district located in this state which provides or has

- 1 authority to provide ambulance service;
- 2 (32) "Professional organization", any organized group or
- 3 association with an ongoing interest regarding emergency medical
- 4 services. Such groups and associations could include those
- 5 representing volunteers, labor, management, firefighters,
- 6 EMT-B's, nurses, EMT-P's, physicians, communications specialists
- 7 and instructors. Organizations could also represent the
- 8 interests of ground ambulance services, air ambulance services,
- 9 fire service organizations, law enforcement, hospitals, trauma
- 10 centers, communication centers, pediatric services, labor unions
- 11 and poison control services;
- 12 (33) "Proof of financial responsibility", proof of ability
- to respond to damages for liability, on account of accidents
- occurring subsequent to the effective date of such proof, arising
- out of the ownership, maintenance or use of a motor vehicle in
- the financial amount set in rules promulgated by the department,
- 17 but in no event less than the statutory minimum required for
- 18 motor vehicles. Proof of financial responsibility shall be used
- 19 as proof of self-insurance;
- 20 (34) "Protocol", a predetermined, written medical care
- 21 guideline, which may include standing orders;
- 22 (35) "Regional EMS advisory committee", a committee formed
- within an emergency medical services (EMS) region to advise
- 24 ambulance services, the state advisory council on EMS and the
- 25 department;
- 26 (36) "Specialty care transportation", the transportation of
- 27 a patient requiring the services of an emergency medical

- 1 technician-paramedic who has received additional training beyond
- 2 the training prescribed by the department. Specialty care
- 3 transportation services shall be defined in writing in the
- 4 appropriate local protocols for ground and air ambulance services
- 5 and approved by the local physician medical director. The
- 6 protocols shall be maintained by the local ambulance service and
- 7 shall define the additional training required of the emergency
- 8 medical technician-paramedic;
- 9 (37) "Stabilize", with respect to an emergency, the
- 10 provision of such medical treatment as may be necessary to
- 11 attempt to assure within reasonable medical probability that no
- 12 material deterioration of an individual's medical condition is
- 13 likely to result from or occur during ambulance transportation
- 14 unless the likely benefits of such transportation outweigh the
- 15 risks;
- 16 (38) "State advisory council on emergency medical
- 17 services", a committee formed to advise the department on policy
- 18 affecting emergency medical service throughout the state;
- 19 "State EMS medical directors advisory committee", a
- 20 subcommittee of the state advisory council on emergency medical
- services formed to advise the state advisory council on emergency
- 22 medical services and the department on medical issues;
- 23 (40) "STEMI" or "ST-elevation myocardial infarction", a
- 24 type of heart attack in which impaired blood flow to the
- 25 patient's heart muscle is evidenced by ST-segment elevation in
- 26 electrocardiogram analysis, and as further defined in rules
- 27 promulgated by the department under sections 190.001 to 190.250;

- 1 (41) "STEMI care", includes education and prevention,
- 2 emergency transport, triage, and acute care and rehabilitative
- 3 services for STEMI that requires immediate medical or surgical
- 4 intervention or treatment;
- 5 (42) "STEMI center", a hospital that is currently
- 6 designated as such by the department to care for patients with
- 7 ST-segment elevation myocardial infarctions;
- 8 (43) "Stroke", a condition of impaired blood flow to a
- 9 patient's brain as defined by the department;
- 10 (44) "Stroke care", includes emergency transport, triage,
- 11 and acute intervention and other acute care services for stroke
- 12 that potentially require immediate medical or surgical
- intervention or treatment, and may include education, primary
- 14 prevention, acute intervention, acute and subacute management,
- prevention of complications, secondary stroke prevention, and
- 16 rehabilitative services;
- 17 (45) "Stroke center", a hospital that is currently
- designated as such by the department;
- 19 (46) "Trauma", an injury to human tissues and organs
- 20 resulting from the transfer of energy from the environment;
- 21 (47) "Trauma care" includes injury prevention, triage,
- 22 acute care and rehabilitative services for major single system or
- 23 multisystem injuries that potentially require immediate medical

A statewide mechanical license holder shall represent only one corporation, firm, institution, organization, or company at one time. A mechanical contractor shall have one license holder responsible for offering Missouri-based field employees eight contact hours of industry training per year; such mechanical contractor shall be responsible for providing proof of training to the division upon request. In the event of a loss of a license holder, a mechanical contractor shall remain in good standing with the division for six months after notifying the division of the change in status. Within the six-month period, a new license holder shall be registered with the division. If no license holder is registered within such six-month period, the division shall declare the mechanical contractor inactive.

4. The division may issue a mechanical contractor license to any person who holds a current and active license to engage in the practice of a mechanical contractor or as a master pipefitter or master plumber issued by any other state, the District of Columbia, or territories of the United States that require standards for licensure, registration, or certification considered to be equivalent or more stringent than the requirements for licensure under sections 324.950 to 324.983.

5. If the contact information of a mechanical contractor's employees is required to fulfill the obligations of a license, such contact information shall be considered a trade secret and therefore not a public record under chapter 610.

324.962. 1.  [324.009. 1. For purposes of this section, the following terms mean:

- (1) "License", a license, certificate, registration, permit, or accreditation that enables a person to legally practice an occupation or profession in a particular jurisdiction; except that "license" shall not include a certificate of license to teach in public schools under section 168.021;
- (2) "Nonresident military spouse", a nonresident spouse of an active duty member of the Armed Forces of the United States who has been transferred or is scheduled to be transferred to the state of Missouri, or who has been transferred or is scheduled to be transferred to an adjacent state and is or will be domiciled in the state of Missouri, or has moved to the state of Missouri on a permanent change-of-station basis;
- (3) "Oversight body", any board, department, agency, or office of a jurisdiction that issues licenses; except, for the purposes of this section, oversight body shall not include the state board of registration for the healing arts, the state board of nursing, the board of pharmacy, the state committee of psychologists, the Missouri dental board, the Missouri board for architects, professional engineers, professional land surveyors and professional landscape architects, the state board of optometry, or the Missouri veterinary medical board;
- (4) "Resident military spouse", a spouse of an active duty member of the Armed Forces of the United States who has been transferred or is scheduled to be transferred to the state of Missouri or an adjacent state and who is a permanent resident of the state of Missouri, who is domiciled in the state of Missouri, or who has Missouri as his or her home of record.
- 2. Any person who is a resident of Missouri, a resident military spouse, or a nonresident military spouse and who holds a valid current license issued by another state, territory of the United States, or the District of Columbia may submit an application for a license in Missouri in the same occupation or profession for which he or she holds the current license, along with proof of current licensure in [the] all other [jurisdiction] jurisdictions, to the relevant oversight body in this state.
 - 3. The oversight body in this state shall[,]:

- (1) Within six months of receiving an application described in subsection 2 of this section from a resident of Missouri, waive any examination, educational, or experience requirements for licensure in this state for the applicant if it determines that the licensing requirements in the jurisdiction that issued the applicant's license are substantially similar to or more stringent than the licensing requirements in Missouri for the same occupation or profession and shall issue such applicant a license under this section if such applicant otherwise meets the requirements of this section; or
- (2) Within thirty days of receiving an application described in subsection 2 of this section from a nonresident military spouse or a resident military spouse, waive any examination, educational, or experience requirements for licensure in this state for the applicant and issue such applicant a license under this section if such applicant otherwise meets the requirements of this section.
- 4. The oversight body shall not waive any examination, educational, or experience requirements for any applicant who is currently under disciplinary action with an oversight body outside the state or who does not hold a valid current license in the other jurisdiction on the date the oversight body receives his or her application under this section.
- 5. The oversight body shall not waive any examination, educational, or experience requirements for any applicant if it determines that waiving the requirements for the applicant may endanger the public health, safety, or welfare.
- 6. Nothing in this section shall prohibit the oversight body from denying a license to an applicant under this section for any reason described in any section associated with the occupation or profession for which the applicant seeks a license.
- 7. This section shall not be construed to waive any requirement for an applicant to pay any fees, post any bonds or surety bonds, or submit proof of insurance associated with the license the applicant seeks.
- 8. This section shall not apply to business, professional, or occupational licenses issued or required by political subdivisions.
- 9. The provisions of this section shall not be construed to alter the authority granted by, or any requirements promulgated pursuant to, any interjurisdictional or interstate compacts adopted by

Missouri statute or any reciprocity agreements with other states [in effect on August 28, 2018, and whenever possible this section shall be interpreted so as to imply no conflict between it and any compact, or any reciprocity agreements with other states in effect on August 28, 2018]. If any conflict arises between the provisions of this section and the provisions of any interjurisdictional or interstate compact or reciprocity agreement, the provisions of such compact or agreement shall prevail. If a conflict arises between the provisions of this section and any federal law or rule, the provisions of the federal law or rule shall prevail.
