1 AMEND House Committee Substitute for House Bill No. 2030, Page 1, Section A, Line 3, by
2 inserting after all of said section and line the following:

3
4 "313.300. 1. Unclaimed prize money shall be retained by the commission for the person
5 entitled thereto for one hundred eighty days after the time at which the prize was awarded. If no
6 claim is made for the prize within one hundred eighty days, the prize money shall be [reverted to the
7 state lottery] deposited into the after school programs special fund as provided in this section.

8 2. The commission shall deposit into the after school programs special fund any monies
9 received from video lottery game operators under subsection 11 of section 313.429.

10 3. (1) There is hereby created in the state treasury the "After School Programs Special
11 Fund", which shall consist of moneys deposited under this section. The state treasurer shall be
12 custodian of the fund. In accordance with sections 30.170 and 30.180, the state treasurer may
13 approve disbursements. The fund shall be a dedicated fund and, upon appropriation, moneys in the
14 fund shall be used solely as provided in this section.

15 (2) Notwithstanding the provisions of section 33.080 to the contrary, any moneys remaining
16 in the fund at the end of the biennium shall not revert to the credit of the general revenue fund.

17 (3) The state treasurer shall invest moneys in the fund in the same manner as other funds are
18 invested. Any interest and moneys earned on such investments shall be credited to the fund.

19 4. Upon appropriation, moneys in the after school programs special fund shall be used to
20 supplement, not supplant, nonlottery educational resources to programs eligible to receive lottery
21 funds. To be eligible for any moneys distributed under this subsection, a program shall be an after
22 school program operated by a public or nonprofit entity with a focus including, but not limited to,
23 academic success, and shall also serve children five years of age or older and under nineteen years
24 of age. The department shall give priority to any program that serves geographic areas of high need
25 as described in section 161.215 or that enrolls high-need children as described in section 162.974 if
26 at least eighty percent of the children enrolled in the program are high-need children."; and

28 Further amend said bill, Page 6, Section 313.429, Lines 93-95, by deleting all of said lines and
29 inserting in lieu thereof the following:

31 "operators shall deposit any unclaimed cash prize associated with a winning ticket that has not been
32 redeemed within one hundred eighty days of issue into the after school programs special fund under
33 section 313.300."; and

35 Further amend said bill and section, Page 10, Line 237, by inserting after the word "schools." the
36 following:

2 "A minimum of fifteen percent of the net proceeds shall be appropriated to public institutions of
3 elementary and secondary education for the sole purpose of funding after school programs in those
4 schools, under section 313.300."; and

6 Further amend said bill, Page 9, Section 313.429, Line 207, by deleting the number "two hundred
7 fifty" and inserting in lieu thereof the number "five hundred"; and

9 Further amend said bill by amending the title, enacting clause, and intersectional references
10 accordingly.
