- 1 2721(b)(1), the department of revenue shall not release the home address of or any information that identifies any vehicle owned 2 3 or leased by any person who is a county, state or federal parole officer $[\tau]$ ; a federal pretrial officer $[\tau]$ ; a peace officer 5 pursuant to section 590.010[7]; a person employed by the Missouri department of corrections; any jailer or corrections officer of 6 7 the state or any political subdivision of the state; a person vested by Article V, Section 1 of the Missouri Constitution with 8 9 the judicial power of the state  $[\tau]$ ; a member of the federal judiciary[7]; or a member of such person's immediate family 10 contained in the department's motor vehicle or driver 11 12 registration records, based on a specific request for such information from any person. Any such person may notify the 13 14 department of his or her status and the department shall protect the confidentiality of the home address and vehicle records on 15 such a person and his or her immediate family as required by this 16 This section shall not prohibit the department from 17 section. 18 releasing information on a motor registration list pursuant to section 32.055 or from releasing information on any officer who 19 20 holds a class A, B or C commercial driver's license pursuant to the Motor Carrier Safety Improvement Act of 1999, as amended, 49 21 22 U.S.C. 31309. 23
  - 32.300. <u>1.</u> In a county where personal property tax records are accessible via computer, and when proof of motor vehicle liability insurance, safety inspections and emission inspections where required are verifiable by computer, the department of revenue shall design and implement a motor vehicle license

Such moneys shall be deposited into the port authority AIM zone fund established under subsection 5 of this section for the purpose of continuing to expand, develop, and redevelop AIM zones identified by the port authority board of commissioners and may be used for managerial, engineering, legal, research, promotion, planning, satisfaction of bonds issued under section 68.040, and any other expenses.
- 5. There is hereby created in the state treasury the "Port Authority AIM Zone Fund", which shall consist of money collected under this section. The state treasurer shall be custodian of the fund and shall approve disbursements from the fund in accordance with sections 30.170 and 30.180 to the port authorities from which the funds were collected, less the pro-rata portion appropriated by the general assembly to be used solely for the administration of this section which shall not exceed ten percent of the total amount collected within the zones of a port authority. 137.115. 1. All other laws to the contrary notwithstanding, the assessor or the assessor's deputies in all counties of this state including the City of St. Louis shall annually make a list of all real and tangible personal property taxable in the assessor's city, county, town or district. Except as otherwise provided in subsection 3 of this section and section 137.078, the assessor shall annually assess all personal property at thirty-three and one-third percent of its true value in money as of January first of each calendar year. The assessor shall annually assess all real property, including any new construction and improvements to real property, and possessory interests in real property at the percent of its true value in money set in subsection 5 of this section. The true value in money of any possessory interest in real property in subclass (3), where such real property is on or lies within the ultimate airport boundary as shown by a federal airport layout plan, as defined by 14 CFR 151.5, of a commercial airport having a FAR Part 139 certification and owned by a political subdivision, shall be the otherwise applicable true value in money of any such possessory

interest in real property, less the total dollar amount of costs 1 paid by a party, other than the political subdivision, towards 2 3 any new construction or improvements on such real property completed after January 1, 2008, and which are included in the 4 5 above-mentioned possessory interest, regardless of the year in 6 which such costs were incurred or whether such costs were 7 considered in any prior year. The assessor shall annually assess all real property in the following manner: new assessed values 8 9 shall be determined as of January first of each odd-numbered year and shall be entered in the assessor's books; those same assessed 10 values shall apply in the following even-numbered year, except 11 for new construction and property improvements which shall be 12 valued as though they had been completed as of January first of 13 14 the preceding odd-numbered year. The assessor may call at the office, place of doing business, or residence of each person 15 required by this chapter to list property, and require the person 16 17 to make a correct statement of all taxable tangible personal 18 property owned by the person or under his or her care, charge or 19 management, taxable in the county. On or before January first of 20 each even-numbered year, the assessor shall prepare and submit a 21 two-year assessment maintenance plan to the county governing body 22 and the state tax commission for their respective approval or 23 modification. The county governing body shall approve and 24 forward such plan or its alternative to the plan to the state tax 25 commission by February first. If the county governing body fails 26 to forward the plan or its alternative to the plan to the state tax commission by February first, the assessor's plan shall be 27

- 1 considered approved by the county governing body. If the state 2 tax commission fails to approve a plan and if the state tax 3 commission and the assessor and the governing body of the county involved are unable to resolve the differences, in order to 4 5 receive state cost-share funds outlined in section 137.750, the 6 county or the assessor shall petition the administrative hearing 7 commission, by May first, to decide all matters in dispute 8 regarding the assessment maintenance plan. Upon agreement of the 9 parties, the matter may be stayed while the parties proceed with 10 mediation or arbitration upon terms agreed to by the parties. The final decision of the administrative hearing commission shall 11 12 be subject to judicial review in the circuit court of the county 13 involved. In the event a valuation of subclass (1) real property 14 within any county with a charter form of government, or within a city not within a county, is made by a computer, computer-15 assisted method or a computer program, the burden of proof, 16 17 supported by clear, convincing and cogent evidence to sustain 18 such valuation, shall be on the assessor at any hearing or 19 appeal. In any such county, unless the assessor proves 20 otherwise, there shall be a presumption that the assessment was 21 made by a computer, computer-assisted method or a computer 22 program. Such evidence shall include, but shall not be limited 23 to, the following:
  - (1) The findings of the assessor based on an appraisal of the property by generally accepted appraisal techniques; and

(2) The purchase prices from sales of at least three comparable properties and the address or location thereof. As

- 1 used in this subdivision, the word "comparable" means that:
- 2 (a) Such sale was closed at a date relevant to the property valuation; and
- (b) Such properties are not more than one mile from the

  site of the disputed property, except where no similar properties

  exist within one mile of the disputed property, the nearest

  comparable property shall be used. Such property shall be within

  five hundred square feet in size of the disputed property, and

  resemble the disputed property in age, floor plan, number of
- 2. Assessors in each county of this state and the City of

  St. Louis may send personal property assessment forms through the

  - 3. The following items of personal property shall each constitute separate subclasses of tangible personal property and shall be assessed and valued for the purposes of taxation at the following percentages of their true value in money:
  - (1) Grain and other agricultural crops in an unmanufactured condition, one-half of one percent;
    - (2) Livestock, twelve percent;

- 21 (3) Farm machinery, twelve percent;
  - (4) Motor vehicles which are eligible for registration as and are registered as historic motor vehicles [pursuant to] under section 301.131 and aircraft which are at least twenty-five years old and which are used solely for noncommercial purposes and are operated less than [fifty] two hundred hours per year or aircraft that are home built from a kit, five percent;

- 1 (5) Poultry, twelve percent; and
- 2 (6) Tools and equipment used for pollution control and
- 3 tools and equipment used in retooling for the purpose of
- 4 introducing new product lines or used for making improvements to
- 5 existing products by any company which is located in a state
- 6 enterprise zone and which is identified by any standard
- 7 industrial classification number cited in subdivision (5) of
- 8 section 135.200, twenty-five percent.
- 9 4. The person listing the property shall enter a true and
- 10 correct statement of the property, in a printed blank prepared
- 11 for that purpose. The statement, after being filled out, shall
- 12 be signed and either affirmed or sworn to as provided in section
- 13 137.155. The list shall then be delivered to the assessor.
- 5. (1) All subclasses of real property, as such subclasses
- are established in Section 4(b) of Article X of the Missouri
- 16 Constitution and defined in section 137.016, shall be assessed at
- 17 the following percentages of true value:
- 18 (a) For real property in subclass (1), nineteen percent;
- 19 (b) For real property in subclass (2), twelve percent; and
- 20 (c) For real property in subclass (3), thirty-two percent.
- 21 (2) A taxpayer may apply to the county assessor, or, if not
- located within a county, then the assessor of such city, for the
- 23 reclassification of such taxpayer's real property if the use or
- 24 purpose of such real property is changed after such property is
- assessed under the provisions of this chapter. If the assessor
- determines that such property shall be reclassified, he or she
- 27 shall determine the assessment under this subsection based on the

- percentage of the tax year that such property was classified in
  each subclassification.
- Manufactured homes, as defined in section 700.010, which are actually used as dwelling units shall be assessed at the same 4 5 percentage of true value as residential real property for the purpose of taxation. The percentage of assessment of true value 7 for such manufactured homes shall be the same as for residential real property. If the county collector cannot identify or find 8 9 the manufactured home when attempting to attach the manufactured home for payment of taxes owed by the manufactured home owner, 10 the county collector may request the county commission to have 11 12 the manufactured home removed from the tax books, and such request shall be granted within thirty days after the request is 13 14 made; however, the removal from the tax books does not remove the tax lien on the manufactured home if it is later identified or 15 found. For purposes of this section, a manufactured home located 16 17 in a manufactured home rental park, rental community or on real 18 estate not owned by the manufactured home owner shall be considered personal property. For purposes of this section, a 19 20 manufactured home located on real estate owned by the manufactured home owner may be considered real property. 21
  - 7. Each manufactured home assessed shall be considered a parcel for the purpose of reimbursement [pursuant to] under section 137.750, unless the manufactured home is deemed to be real estate [as defined in] under subsection 7 of section 442.015 and assessed as a realty improvement to the existing real estate parcel.

8. Any amount of tax due and owing based on the assessment of a manufactured home shall be included on the personal property tax statement of the manufactured home owner unless the manufactured home is deemed to be real estate [as defined in] under subsection 7 of section 442.015, in which case the amount of tax due and owing on the assessment of the manufactured home as a realty improvement to the existing real estate parcel shall be included on the real property tax statement of the real estate owner.

- The assessor of each county and each city not within a county shall use the trade-in value published in the October issue of the National Automobile Dealers' Association Official Used Car Guide, or its successor publication, as the recommended quide of information for determining the true value of motor vehicles described in such publication. The assessor shall not use a value that is greater than the average trade-in value in determining the true value of the motor vehicle without performing a physical inspection of the motor vehicle. For vehicles two years old or newer from a vehicle's model year, the assessor may use a value other than average without performing a physical inspection of the motor vehicle. In the absence of a listing for a particular motor vehicle in such publication, the assessor shall use such information or publications which in the assessor's judgment will fairly estimate the true value in money of the motor vehicle.
  - 10. Before the assessor may increase the assessed valuation of any parcel of subclass (1) real property by more than fifteen

- 1 percent since the last assessment, excluding increases due to new
- 2 construction or improvements, the assessor shall conduct a
- 3 physical inspection of such property.
- 4 11. If a physical inspection is required, [pursuant to]
- 5 <u>under</u> subsection 10 of this section, the assessor shall notify
- 6 the property owner of that fact in writing and shall provide the
- 7 owner clear written notice of the owner's rights relating to the
- 8 physical inspection. If a physical inspection is required, the

  - (a) The movement of a motor vehicle or trailer by any person or motor carrier other than a dealer over any public highway, under its own power singly, or in a fixed combination of two or more vehicles, for the purpose of delivery for sale or for delivery either before or after sale;
    - (b) The movement of any vehicle or vehicles, not owned by the transporter, constituting the commodity being transported, by a person engaged in the business of furnishing drivers and operators for the purpose of transporting vehicles in transit from one place to another by the driveaway or towaway methods; or
    - (c) The movement of a motor vehicle by any person who is lawfully engaged in the business of transporting or delivering vehicles that are not the person's own and vehicles of a type

- otherwise required to be registered, by the driveaway or towaway
- 2 methods, from a point of manufacture, assembly or distribution or
- 3 from the owner of the vehicles to a dealer or sales agent of a
- 4 manufacturer or to any consignee designated by the shipper or
- 5 consignor;
- 6 (14) "Dromedary", a box, deck, or plate mounted behind the
- 7 cab and forward of the fifth wheel on the frame of the power unit
- 8 of a truck tractor-semitrailer combination. A truck tractor
- 9 equipped with a dromedary may carry part of a load when operating
- independently or in a combination with a semitrailer;
- 11 (15) "Farm tractor", a tractor used exclusively for
- 12 agricultural purposes;
- 13 (16) "Fleet", any group of ten or more motor vehicles owned
- 14 by the same owner;
- 15 (17) "Fleet vehicle", a motor vehicle which is included as
- 16 part of a fleet;
- 17 (18) "Fullmount", a vehicle mounted completely on the frame
- of either the first or last vehicle in a saddlemount combination;
- 19 (19) "Gross weight", the weight of vehicle and/or vehicle
- 20 combination without load, plus the weight of any load thereon;
- 21 (20) "Hail-damaged vehicle", any vehicle, the body of which
- 22 has become dented as the result of the impact of hail;
- 23 (21) "Highway", any public thoroughfare for vehicles,
- including state roads, county roads and public streets, avenues,
- 25 boulevards, parkways or alleys in any municipality;
- 26 (22) "Improved highway", a highway which has been paved
- 27 with gravel, macadam, concrete, brick or asphalt, or surfaced in

- 1 such a manner that it shall have a hard, smooth surface;
- 2 (23) "Intersecting highway", any highway which joins
- 3 another, whether or not it crosses the same;
- 4 (24) "Junk vehicle", a vehicle which:
  - (a) Is incapable of operation or use upon the highways and has no resale value except as a source of parts or scrap; or

  vehicle", any not-for-hire commercial motor vehicle the operation

  of which is confined to:
  - (a) An area that extends not more than a radius of one hundred miles from its home base of operations when transporting its owner's machinery, equipment, or auxiliary supplies to or from projects involving soil and water conservation, or to and from equipment dealers' maintenance facilities for maintenance purposes; or
  - (b) An area that extends not more than a radius of fifty miles from its home base of operations when transporting its owner's machinery, equipment, or auxiliary supplies to or from projects not involving soil and water conservation.

Nothing in this subdivision shall be construed to prevent any motor vehicle from being registered as a commercial motor vehicle or local commercial motor vehicle;

- vehicle whose operations are confined to a municipality and that area extending not more than fifty miles therefrom, or a commercial motor vehicle whose property-carrying operations are confined solely to the transportation of property owned by any person who is the owner or operator of such vehicle to or from a farm owned by such person or under the person's control by virtue of a landlord and tenant lease; provided that any such property transported to any such farm is for use in the operation of such farm;
- (28) "Local log truck", a commercial motor vehicle which is registered pursuant to this chapter to operate as a motor vehicle on the public highways of this state, used exclusively in this state, used to transport harvested forest products, operated solely at a forested site and in an area extending not more than a one hundred mile radius from such site, carries a load with dimensions not in excess of twenty-five cubic yards per two axles with dual wheels, and when operated on the national system of interstate and defense highways described in 23 U.S.C. Section 103, as amended, or outside the one hundred mile radius from such site with an extended distance local log truck permit, such vehicle shall not exceed the weight limits of section 304.180, does not have more than four axles, and does not pull a trailer which has more than three axles. Harvesting equipment which is

used specifically for cutting, felling, trimming, delimbing, debarking, chipping, skidding, loading, unloading, and stacking may be transported on a local log truck. A local log truck may not exceed the limits required by law, however, if the truck does exceed such limits as determined by the inspecting officer, then notwithstanding any other provisions of law to the contrary, such truck shall be subject to the weight limits required by such sections as licensed for eighty thousand pounds;

- "Local log truck tractor", a commercial motor vehicle which is registered under this chapter to operate as a motor vehicle on the public highways of this state, used exclusively in this state, used to transport harvested forest products, operated at a forested site and in an area extending not more than a one hundred mile radius from such site, operates with a weight not exceeding twenty-two thousand four hundred pounds on one axle or with a weight not exceeding forty-four thousand eight hundred pounds on any tandem axle, and when operated on the national system of interstate and defense highways described in 23 U.S.C. Notwithstanding any provision of this section to the contrary, an articulated bus, comprised of two or more sections connected by a flexible joint or other mechanism, may be up to sixty feet in length, not including safety bumpers which may extend one foot in front and one foot in the rear, and not including bicycle storage racks which may extend over the safety bumper by up to five feet when in the down position

- 1 transporting a bicycle. The term "safety bumper" means any
- 2 device which may be fitted on an existing bumper or which
- 3 replaces the bumper and is so constructed, treated, or
- 4 manufactured that it absorbs energy upon impact.
- 5 S. No combination of truck-tractor and semitrailer or

(1) Automobile transporters, boat transporters, truck-trailer boat transporter combinations, and stinger-steered combination boat transporters having a length not in excess of seventy-five feet may be operated on the interstate highways of this state and such other highways as may be designated by the commission for the operation of such vehicles plus a distance not to exceed ten miles from such interstate or designated highway. All length provisions regarding automobile or boat transporters, truck-trailer boat transporter combinations and stinger-steered combination boat transporters shall include a semitrailer length not to exceed fifty-three feet and are exclusive of front and rear overhang, which shall be no greater than a three-foot front overhang and no greater than a four-foot rear overhang.
- (2) Stinger-steered combination automobile transporters having a length not in excess of eighty feet may be operated on the interstate highways of this state and such other highways as may be designated by the commission for the operation of such vehicles plus a distance not to exceed ten miles from such

- interstate or designated highway. All length provisions regarding stinger-steered automobile combination transporters are 2 3 exclusive of front and rear overhang, which shall be no greater
- than a four-foot front overhang and no greater than a six-foot 4 5 rear overhang.

- Automobile transporters may transport cargo or general 6 7 freight on a backhaul, as long as in compliance with weight limitations for a truck-tractor and semitrailer combination as 8 9 outlined in section 304.180.
  - Driveaway saddlemount combinations having a length not in excess of ninety-seven feet may be operated on the interstate highways of this state and such other highways as may be designated by the commission for the operation of such vehicles plus a distance not to exceed ten miles from such interstate or designated highway. Saddlemount combinations must comply with the safety requirements of Section 393.71 of Title 49 of the Code of Federal Regulations and may contain no more than three saddlemounted vehicles and one fullmount.

As used in this chapter the term "implements of husbandry" means all self-propelled machinery operated at speeds of less than thirty miles per hour, specifically designed for, or especially adapted to be capable of, incidental over-the-road and primary offroad usage and used exclusively for the application of commercial plant food materials or agricultural chemicals, and not specifically designed or intended for transportation of such chemicals and materials.
- 15. Sludge disposal units may be operated on all state highways other than the interstate system. Such units shall not exceed one hundred thirty-eight inches in width and may be equipped with over-width tires. Such units shall observe all axle weight limits. The commission shall issue special permits for the movement of such disposal units and may by such permits restrict the movements to specified routes, days and hours.
- 304.172. No vehicle or combination of vehicles shall be moved or operated on any highway in this state having a greater weight than twenty thousand pounds on one axle, no combination of vehicles operated by transporters of general freight over regular routes as defined in section 390.020 shall be moved or operated on any highway of this state having a greater weight than the vehicle manufacturer's rating on a steering axle with the maximum weight not to exceed twelve thousand pounds on a steering axle, and no vehicle shall be moved or operated on any state highway of this state having a greater weight than thirty-four thousand pounds on any tandem axle; the term "tandem axle" shall mean a group of two or more axles, arranged one behind another, the distance between the extremes of which is more than forty inches and not more than ninety-six inches apart.
  - 2. An "axle load" is defined as the total load transmitted to the road by all wheels whose centers are included between two parallel transverse vertical planes forty inches apart, extending across the full width of the vehicle.
  - 3. Subject to the limit upon the weight imposed upon a highway of this state through any one axle or on any tandem axle, the total gross weight with load imposed by any group of two or more consecutive axles of any vehicle or combination of vehicles shall not exceed the maximum load in pounds as set forth in the following table:

- Notwithstanding the above table, two consecutive sets of tandem axles may carry a gross load of thirty-four thousand pounds each if the overall distance between the first and last axles of such consecutive sets of tandem axles is thirty-six feet or more.
  - 4. Whenever the state highways and transportation commission finds that any state highway bridge in the state is in such a condition that use of such bridge by vehicles of the weights specified in subsection 3 of this section will endanger the bridge, or the users of the bridge, the commission may establish maximum weight limits and speed limits for vehicles using such bridge. The governing body of any city or county may grant authority by act or ordinance to the commission to enact the limitations established in this section on those roadways within the purview of such city or county. Notice of the weight limits and speed limits established by the commission shall be given by posting signs at a conspicuous place at each end of any such bridge.
    - 5. Nothing in this section shall be construed as permitting lawful axle loads, tandem axle loads or gross loads in excess of those permitted under the provisions of P.L. 97-424 codified in

- Title 23 of the United States Code (23 U.S.C. Section 101, et al.), as amended.
- 6. Notwithstanding the weight limitations contained in this section, any vehicle or combination of vehicles operating on highways other than the interstate highway system may exceed single axle, tandem axle and gross weight limitations in an amount not to exceed two thousand pounds. However, total gross weight shall not exceed eighty thousand pounds, except as provided in subsections 9, 10, 12, and 13 of this section.

- 7. Notwithstanding any provision of this section to the contrary, the commission shall issue a single-use special permit, or upon request of the owner of the truck or equipment shall issue an annual permit, for the transporting of any crane or concrete pump truck or well-drillers' equipment. The commission shall set fees for the issuance of permits and parameters for the transport of cranes pursuant to this subsection. Notwithstanding the provisions of section 301.133, cranes, concrete pump trucks, or well-drillers' equipment may be operated on state-maintained roads and highways at any time on any day.

Section 127, as amended. In no case shall the additional weight increase allowed by this subsection be greater than five hundred fifty pounds. Upon request by an

This section and chapter 536 are nonseverable and if any of the powers vested 15 with the general assembly pursuant to chapter 536 to review, to 16 17 delay the effective date, or to disapprove and annul a rule are 18 subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2014, 19 20 shall be invalid and void.

12. Notwithstanding any provision of this section to the contrary, emergency vehicles designed to be used under emergency conditions to transport personnel and equipment and to <u>support</u> the suppression of fires and mitigate hazardous situations may have a maximum gross vehicle weight of eighty-six thousand pounds inclusive of twenty-four thousand pounds on a single steering axle; thirty-three thousand five hundred pounds on a single drive

such emergency vehicles shall only operate on the Dwight D.

Notwithstanding any provision of this section to the contrary, a vehicle operated by an engine fueled primarily by natural gas may operate upon the public highways of this state in excess of the vehicle weight limits set forth in this section by an amount that is equal to the difference between the weight of the vehicle attributable to the natural gas tank and fueling system carried by that vehicle and the weight of a comparable diesel tank and fueling system. In no event shall the maximum gross vehicle weight of the vehicle operating with a natural gas engine exceed eighty-two thousand pounds.
- 15 <u>305.800.</u> As used in sections 305.800 to 305.810, the following terms mean:
  - (1) "Abandoned aircraft", an aircraft left in a wrecked, inoperative, or partially dismantled condition at an airport; or an aircraft that has remained in an idle state at an airport for forty-five consecutive calendar days without a contractual agreement between the owner or operator of the aircraft and the airport for use of the airport premises;
  - (2) "Airport superintendent", the person or group of people authorized to make decisions on behalf of an airport;
  - (3) "Derelict aircraft", any aircraft that is not in a flyable condition, does not have a current certificate of airworthiness issued by the Federal Aviation Administration, and

- is not in the process of actively being repaired.
- 2 305.802. 1. If a derelict aircraft or abandoned aircraft
- 3 is discovered on airport property, the airport superintendent
- 4 <u>shall:</u>
- 5 <u>(1) Make a record of the date the aircraft was discovered</u>
- 6 <u>on the airport property; and</u>
- 7 (2) Inquire as to the name and address of any person having
- 8 <u>an equitable or legal interest in the aircraft, including the</u>
- 9 owner and any lienholders, by:
- 10 <u>(a) Contacting the Federal Aviation Administration</u>,
- 11 aircraft registration branch, and making a diligent search of the

(1) If the owner of the aircraft is unknown or cannot be found after the inquiry required under subdivision (2) of subsection 1 of this section, the airport superintendent shall place a notice upon the aircraft in a conspicuous place containing the information required under subdivisions (2), (3), (4), (5), and (6) of subsection 2 of this section.
  - (2) The notice required under subdivision (1) of this subsection shall be not less than eight inches by ten inches and shall be laminated or otherwise sufficiently weatherproof to withstand normal exposure to rain, snow, and other conditions.

If the owner or other interested party has not removed the aircraft from the airport and paid in full all accrued fees and charges for the use of the airport and for the transportation, storage, and removal of the aircraft, or shown reasonable cause for the failure to do so within thirty calendar days of the airport superintendent posting notice under section

- (1) [(a) All new, untitled current model year recreation vehicle inventory, acquired from the manufacturer, which has not been used (except for demonstration purposes), altered or damaged to the extent that such damage must be disclosed to the consumer pursuant to section 407.1343, at one hundred percent of the net invoice cost, including transportation, less applicable rebates and discounts to the dealer; and
- (b) All new, untitled recreation vehicle inventory of the prior model year, acquired from the manufacturer, provided the prior model year vehicles have not been altered, used (except for demonstration purposes) or damaged to the extent that such damage

must be disclosed to the consumer pursuant to section 407.1343, and were drafted on the dealer's financing source or paid within one hundred twenty days prior to the effective date of the termination, cancellation, or nonrenewal.

- In the event any of the vehicles repurchased pursuant to this subdivision are damaged, but do not trigger the consumer disclosure requirement, the amount due the dealer shall be reduced by the cost to repair the vehicle. Damage prior to delivery to dealer that is disclosed at the time of delivery will not disqualify repurchase under this provision] All new, untitled recreation vehicle inventory, acquired from the manufacturer in the previous eighteen months, which has not been altered or damaged to the extent that such damage must be disclosed to the consumer pursuant to section 407.1343, at one hundred percent of the net invoice cost, including transportation, less applicable rebates and discounts to the dealer;
- (2) All current and undamaged manufacturer's accessories and proprietary parts sold to the dealer for resale, if accompanied by the original invoice, at one hundred five percent of the original net price paid to the manufacturer to compensate the dealer for handling, packing, and shipping the parts; and
- (3) Any fully and correctly functioning diagnostic equipment, special tools, current signage and other equipment and machinery, at one hundred percent of the dealer's net cost plus freight, destination, delivery and distribution charges and sales taxes, if any, provided it was purchased by the dealer within

- 1 five years before termination and upon the manufacturer's request
- 2 and can no longer be used in the normal course of the dealer's
- 3 ongoing business. The manufacturer shall pay the dealer within
- 4 thirty days of receipt of [the returned] all items returned for
- 5 repurchase under this section.
