FISCAL ANALYSIS

ASSUMPTION

In response to a similar proposal from 2019 (HB 53), officials from the **Office of the Governor** deferred to the Office of Administration.

Officials from the **Office of Administration (OA)** assume that the Governor's Office will delegate this responsibility to OA. This information is currently available on a web page, and it is assumed that this legislation would require OA to update that web page as needed. Based on an estimated 1,300 positions that are or should be listed on this page, and an estimated 30 minutes to track changes and update each position every year, this legislation is estimated to cost \$11,700 to implement. While all of these positions may not need to be updated every year, there is no way to know how many changes would actually occur in a given year. The calculation for the estimated need is detailed below.

1,300 positions that could require updating

x 30 minutes per position

=39,000 minutes / 60

=650 hours of staff time each year

650 hours

x \$18/hr

=\$11,700 cost of implementation

Oversight assumes the Office of Administration could implement the proposal with existing resources and will not show a fiscal impact.

Officials from the **Department of Transportation** assume no fiscal impact from this proposal.
