FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could require additional resources.

Officials from the **Department of Revenue** and **Office of State Courts Administrator** both assume the proposal will have no fiscal impact on their organization.

Officials from the **Platte County Board of Elections** anticipate a marked increase in Provisional-No ID ballots cast at every election with the proposal to limit the types of voter identification accepted at the poll site. The increase will require additional specifically marked Provisional ballots at each poll site, thus increasing the costs for each election by \$350.00.

Officials from the **Kansas City Election Board** assume if the proposal becomes law, election day judges would need to be retrained at a cost of \$35,000.

Oversight notes there could be additional training costs in FY 2021, as estimated by the Kansas City Election Board. Therefore, Oversight will assume an unknown potential cost to local political subdivisions in FY 2021. Oversight will assume local election authorities will not incur a material additional cost beyond FY 2021 from this proposal.

Officials from the **Jackson County Election Board**, **St. Louis County Board of Elections**, and **Madison County** each assume the proposal will have no fiscal impact on their organization.

ASSUMPTION (continued)

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. For a general listing of political subdivisions included in our database, please contact the Oversight Division.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill modifies election laws. In its main provisions the bill:

- (1) Requires candidates filing their declaration of candidacy with the Secretary of State to pay their fee to the treasurer of the appropriate political party committee;
- (2) Requires persons voting in person by use of an absentee ballot to establish their identity under Section 115.427, RSMo;

FISCAL DESCRIPTION (continued)

(3) Allows voters without personal identification at a polling place to vote a provisional ballot which will be counted based upon a certification process and the return of documentation or by a signature verification process conducted by the election authority;

(4) Repeals certain affidavit and notice requirements under Section 115.427; and

(5) Authorizes the Missouri Secretary of State to subpoena specified records for the purpose of investigating all classifications of election offenses and other specified offenses, but terminates such authority after August 28, 2025.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
