## FISCAL ANALYSIS

### ASSUMPTION

#### Section 344.030 - Nursing Home Administrator License

Officials from the **Department of Health and Senior Services - Division of Regulation and Licensure (DHSS)** state that the proposed legislation modifies the requirements for obtaining an initial nursing home administrator license by adding an associate degree or higher from an accredited academic institution. Further, the bill extends the number of days to 120 from 90 that a temporary emergency license is valid.

DHSS anticipates minimal time and expense as a result of these changes and that they can be absorbed; however, until the FY 2021 budget is final, the department cannot identify specific funding sources.

**Oversight** notes that DHSS has stated expenses related to the proposal can be absorbed, therefore this proposal will not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
