## FISCAL ANALYSIS

## ASSUMPTION

Officials at the **Office of the Secretary of State** assume all funds remaining in Fund 0770, approximately \$2,538, will be transferred to the General Revenue Fund on 1/1/21.

Officials at the **Office of the State Treasurer** assumes no fiscal impact from this proposal. As of November 27, 2019, there is \$2,536.12 in the fund.

Officials at the **Office of Administration** assumes no fiscal impact from this proposal.

**Oversight** notes that the Office of the State Treasurer and the Office of Administration have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

The City of St. Louis did not respond to **Oversight's** request for fiscal impact.

**Oversight** notes the MO State Archives-St. Louis Fund had an ending balance of 2,539.48 on 12/31/19. Oversight notes the fund (0770) has had the following activity in the previous fiscal years:

#### FISCAL DESCRIPTION

This bill repeals the laws authorizing the Secretary of State to open and maintain an archival facility in the City of St. Louis and the Missouri State Archives - St. Louis Trust Fund.

This bill requires that all unobligated funds in the Missouri State Archives - St. Louis Trust Fund on January 1, 2021, shall be transferred to the State General Revenue Fund.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
