FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State** assume the proposal will have no fiscal impact on their organization.

Oversight notes that the Office of the Secretary of State has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for this office.

In response to a previous version, officials from the **Kansas City Election Board** assumed legal notices to notify the public about the absentee satellite voting locations would be \$5,000 and each voting location would cost \$25,000 to staff and run. We generally have 5 locations for larger elections (5 X \$25,000 = \$125,000) and 2 locations for smaller elections (2 X \$25,000 = \$50,000).

Oversight notes there could be a potential increase in absentee ballots if this proposal were to be enacted. We are unable to determine how many additional individuals will cast an absentee ballot; therefore, Oversight will reflect an unknown fiscal impact for the additional cost to local election authorities.

Officials from the assume the **Platte County Board of Elections** and **St. Louis County Board of Elections** both proposal will have no fiscal impact on their organization.

In response to a previous version, officials from the Livingston County Clerk, Madison County Clerk, Laclede County Clerk, and Scotland County Clerk each assumed the proposal will have no fiscal impact on their organization.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill allows qualified voters to vote in person by absentee ballot without providing a reason. Voting by mail using absentee ballots will continue to require a reason specified under Section 115.277, RSMo.

The bill also increases the distance requirement for certain electioneering activities at polling places from 25 feet to 100 feet.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
