#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Missouri House of Representatives** state no fiscal impact is anticipated. Joint Committee expenses are typically covered using the Senate's Joint Continent Expenses appropriation.

Officials from the **Missouri State Senate (Senate)** state this proposed legislation, as written, does not allow for compensation from the Joint Contingent appropriation. Therefore, the Senate anticipates a negative fiscal impact to the Senate Contingent appropriation for four senators to attend committee meetings. It will cost the Senate approximately \$455 per meeting.

Oversight notes this proposed legislation establishes the Joint Committee on the Missouri Constitutional Convention for which the committee shall consider whether convening a constitutional convention is in the best interest of the state. The committee shall be composed of eight members of which four are appointed by the Speaker of the House of Representatives and four appointed by the President Pro Tempore of the Senate; each shall appoint two members from the majority party and two members from the minority party. The members of the committee would serve without compensation but could seek reimbursement for actual and necessary expenses.

This proposed legislation would require that the committee meet, at minimum, each quarter.

**Oversight** assumes the Senate could anticipate a total cost of approximately \$1,820 annually (\$455 x 4 meetings per year). Oversight further assumes, as the cost to the Senate Contingent appropriation is anticipated to be minimal, that such costs could be absorbed. Therefore, for the purposes of this fiscal note, Oversight will assume a zero fiscal impact for this proposal.

Oversight notes the Legislative Research Division and the Missouri Secretary of State's Office have stated the proposed legislation would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these organizations.
