### FISCAL ANALYSIS

### ASSUMPTION

Officials at the **Office of the Secretary of State**, the **Office of the State Courts Administrator** and the **Department of Natural Resources** each assume no fiscal impact to their respective agencies from this proposal.

Officials at the **St. Louis County Board of Elections** and the **Platte County Board of Elections** each assume no fiscal impact to their respective entities from this proposal.

In response to a previous version, officials at the **Jackson County Election Board** and the **Metropolitan St. Louis Sewer District** each assumed no fiscal impact to their respective entities from this proposal.

**Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

**Oversight** notes it will be up to the qualified voters residing within each existing district to decide if they want the two districts to consolidate the public water supply district into the reorganized common sewer district. Oversight notes user fees on the property located within the sanitary sewer improvement area may go towards paying for all or parts of improvements and service, including the cost of principal or interest on temporary notes and revenue bonds. Therefore, Oversight will reflect a \$0 fiscal note impact for this proposal.
