FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could require additional resources.

Officials from the Kansas City Election Board, Jackson County Election Board, Platte County Board of Elections, and St. Louis County Board of Elections each assume the proposal will have no fiscal impact on their organization.

Oversight notes that the above local election authorities have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

Oversight notes the proposal creates a new class one election offense, which are deemed felonies connected with the exercise of the right of suffrage. Conviction of any of these offenses shall be punished by imprisonment of not more than five years or by fine of not less than \$2,500, but not more than \$10,000 or by both such imprisonment and fine. Oversight notes according to the Office of the State Courts Administrator, there were no charges filed under this section for the last two years. Oversight will assume any fiscal impact from the changes in the bill will be minimal.
