FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State (SOS)** and **Department of Revenue (DOR)** both assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Kansas City Election Board** assume the proposal will have little to no fiscal impact on their operations.

Oversight notes that the SOS shall provide written notice to the registered voter with instructions for re-registration if voter has been removed from the voter registration system after five years of inactivity. Currently, local election authorities may have the voting records inspected and may investigate the qualifications of any person who has not voted or transferred his registration within the four (changed to 5 with this proposal) preceding calendar years. Oversight is unable to determine how many voters that this will affect, if any. Therefore, Oversight will reflect zero fiscal impact.

Officials from the St. Louis County Board of Elections, Platte County Board of Elections, Jackson County Election Board, and Madison County each assume the proposal will have no fiscal impact on their organization.

Oversight notes that the St. Louis County Board of Elections, Platte County Board of Elections, Jackson County Election Board, and Madison County have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not.
