FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration** state the Missouri Constitution Article III, Section 3 establishes and requires the non-partisan state demographer to create a tentative plan of apportionment and map of the proposed districts. While the state demographer is housed within the Office of Administration, the non-partisan state demographer is not. Consequently, this proposal has no impact on the Office of Administration.

Officials from the **Department of Corrections (DOC)** state the department currently asks offenders during their diagnostic interview what kind of home environment they lived in prior to incarceration and where, but this is not necessarily their permanent place of residence. The department assumes that the address provided by the offender will be the address provided to the state demographer. DOC assumes the proposal would not fiscally impact their agency.

Officials from the **State Auditor's Office** assume the proposal will have no fiscal impact on their organization.

Oversight notes that the Office of Administration, the Department of Corrections and State Auditor's Office have each stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note. Oversight assumes this bill could change future boundaries of legislative districts; however, Oversight assumes it would not create a direct fiscal impact to the state or local political subdivisions.
