#### FISCAL ANALYSIS

#### ASSUMPTION

Officials from the **Office of the Secretary of State**, **Platte County Board of Elections**, **Kansas City Election Board**, **Jackson County Election Board**, and **St. Louis County Board of Elections** each assume the proposal will have no fiscal impact on their organization.

**Oversight** notes that the Office of the Secretary of State, Platte County Board of Elections, Kansas City Election Board, Jackson County Election Board, and St. Louis County Board of Elections has each stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other 1<sup>st</sup> class county clerks were requested to respond to this proposed legislation but did not.
