#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **City of Kansas City (CKC)** assume this legislation will have a negative fiscal impact on the CKC. This legislation provides a separate cause of action to an entity to sue the CKC when it enforces its own ordinances. This could increase litigation against the CKC and make it vulnerable to claims for damages.

**Oversight** notes there could be an increase in lawsuits against political subdivisions being sued by residents, tenants or landlords if the political subdivision enforces or attempts to enforce an ordinance regarding a public nuisance issue. Oversight is unclear how much of an impact this could have on local political subdivisions and how many lawsuits could potentially be brought against the local political subdivision from the enactment of this legislation. Therefore, Oversight will assume a \$0 or unknown potential cost to local political subdivisions from this proposal.

Officials at the Office of the State Courts Administrator, the Missouri Highway Patrol, the Department of Health and Senior Services, the Department of Mental Health, the Department of Social Services, the Department of Labor and Industrial Relations, the Office of the State Public Defender and the Office of Prosecution Services each assume no fiscal impact to their respective agencies from this proposal.

Officials at the City of Springfield, the Boone County Sheriff's Department, the St. Louis County Police Department, the Springfield Police Department and the St. Louis County Department of Justice Services each assume no fiscal impact to their respective entities from this proposal.

**Oversight** notes the Office of the State Courts Administrator, the Missouri Highway Patrol, the Department of Health and Senior Services, the Department of Mental Health, the Department of Social Services, the Department of Labor and Industrial Relations, the Office of the State Public Defender, the Office of Prosecution Services, the City of Springfield, the Boone County Sheriff's Department, the St. Louis County Police Department, the Springfield Police Department and the St. Louis County Department of Justice Services have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

# FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

### FISCAL DESCRIPTION

This bill prohibits requests to law enforcement or emergency services for assistance from being considered a public nuisance.

Political subdivisions are prohibited from penalizing a resident, tenant, or landlord for a contact made for police or emergency assistance by or on behalf of a victim of abuse, crime, or an individual in an emergency, if the contact was reasonably believed to be necessary or is actually necessary.

# FISCAL DESCRIPTION (continued)

If a political subdivision attempts to enforce an ordinance in violation of this prohibition, the resident, tenant, or landlord may file civil suit against the political subdivision for various remedies including a cease and desist order, compensatory damages, attorney's fees, court costs, and other equitable relief.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
