FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the Secretary of State** and the **State Tax Commission** each assume no fiscal impact to their respective agencies from this proposal.

In response to a previous version, officials at the **City of Riverside** assumed no fiscal impact from this proposal.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other 4th class cities were requested to respond to this proposed legislation, but did not. A general listing of political subdivisions included in our database is available upon request.

Oversight notes this proposal allows the mayor of a 4th class city to appoint a member to a local board or commission if they own real property or a business in the city. Oversight assumes the proposal will not have a direct fiscal impact.
