## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Revenue (DOR)** assume the proposal will have no fiscal impact on their organization. DOR notes it is current policy to accept residency verification documents in an electronic format for non-REAL ID compliant transactions as long as the electronic document meets minimum requirements. Per the federal REAL ID of 2005, images of the source documents presented for a REAL ID compliant card must be scanned and retained for a minimum of ten years. The requirement to scan the documents restricts the ability to accept a visual verification of an electronic document.

**Oversight** notes that DOR has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for DOR.

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
