FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the State Courts Administrator (OSCA)** assume no fiscal impact from this proposal.

Officials at the **Missouri Highway Patrol** assume this legislation prohibits making official court records available to the public via any automated case management system of any court of the state. The Patrol interprets this as meaning accessing the court record via an automated court case management system. This legislation also appears to not affect the Central Repository in relation to background checks. Therefore, the Highway Patrol anticipates no fiscal impact.

Officials at the **Office of the State Public Defender** and the **Office of Prosecution Services** each assume no fiscal impact to their respective agencies from this proposal.

Officials at the **City of Kansas City**, the **City of Springfield**, the **Springfield Police Department** and the **St. Louis County Department of Justice Services** each assume no fiscal impact to their respective entities from this proposal.

In response to a previous version, officials at the **St. Louis County Police Department** assumed no fiscal impact from this proposal.

Oversight notes the Office of the State Courts Administrator, the Missouri Highway Patrol, the Office of Prosecution Services, the Office of the State Public Defender, the City of Kansas City, the City of Springfield, the St. Louis County Police Department, the Springfield Police Department and the St. Louis County Department of Justice Services have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these organizations.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other police and sheriff's departments were requested to respond to this proposed legislation, but did not. A general listing of political subdivisions included in our database is available upon request.
