FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the State Courts Administrator** assume there may be some impact but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

In response to a previous version, officials at the **Department of Corrections** assumed this legislation modifies various Supreme Court rules relating to criminal procedure. These changes are not believed to cause any fiscal impact to the department, assuming they are not prohibiting the use of video court. Should the effect of the legislation be to do so, there would be an impact to the department.

During calendar year 2019, we conducted over 3,000 video court appearances for felony or misdemeanor offenses. This reduces staff workload in having to prepare an offender for outcount to attend these hearings. In addition, video court hearings improve public safety as offenders do not require transport in the community. It also allows the offender to resolve any outstanding legal issues prior to their release.

Officials at the Office of the Attorney General, the Department of Mental Health, the Office of Prosecution Services, the Department of Commerce and Insurance and the Office of the State Public Defender each assume no fiscal impact to their respective agencies from this proposal.

Oversight notes the Office of the State Courts Administrator, the Department of Corrections, the Office of the Attorney General, the Department of Commerce and Insurance, the Department of Mental Health, the Office of Prosecution Services and the Office of the State Public Defender have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.
