### **ASSUMPTION**

## §575.095 - Tampering with a judicial officer

Officials from the **Department of Corrections (DOC)** state this proposal modifies the offense of tampering with a judicial officer, by expanding the definition of judicial officer to include a current or former judge. This has the potential impact of creating a new class D felony offense.

In FY 2019, there were three new admissions for violation of section 575.095 as a class D felony. For each new class D felony, the department estimates three people will be sentenced to prison and five to probation. The average sentence for a non-violent class D felony offense is 5 years, of which 2.8 years will be served in prison with 1.7 years to first release. The remaining 2.2 years will be on parole. Probation sentences will be 3 years.

The cumulative impact on the department is estimated to be 8 additional offenders in prison and 16 on field supervision with a net population change of 24 offenders by FY 2023.

## ASSUMPTION (continued)

Officials from the **Missouri Office of Prosecution Services (MOPS)** assume the proposal will have no measurable fiscal impact on MOPS.

Oversight notes the Department of Public Safety - Missouri State Highway Patrol, the Office of State Courts Administrator, and the State Public Defender's Office have each stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.
