FISCAL ANALYSIS

ASSUMPTION

Officials from the Office of the Secretary of State (SOS), Missouri Senate, Attorney General's Office, and Missouri House of Representatives each assume the proposal will have no fiscal impact on their organization.

Officials from the **State Auditor's Office** assume the proposal will have no fiscal impact on their organization. Any impact can be absorbed through current appropriations.

Oversight notes that the above agencies have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the Jackson County Election Board, Kansas City Election Board, Platte County Board of Elections, and St. Louis County Board of Elections each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the above agencies have each stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.
