#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the Department of Higher Education and Workforce Development, Office of the Governor, State Technical College of Missouri, University of Central Missouri, University of Missouri System, El Dorado Springs R-2 School District, and Wellsville-Middletown School District assume this bill has no fiscal impact.

Officials at the **Missouri State Senate** assume this bill has a (\$331.53) fiscal impact per task force meeting (257 miles X .43 miles) for a cost of \$110.33 per attendee.

**Oversight** assumes that each of the eighteen members will be reimbursed roughly \$110.33 per meeting, for a cost of \$1,986 per meeting. If three meetings are held during a year, this would equate to roughly \$6,000 annually in reimbursement expenses. Oversight assumes this amount is not material and will not reflect it on the fiscal note.

**Oversight** received no response from the MEC, but assumes they can absorb any additional enforcement activities that this bill may require. Upon receipt of their response, Oversight may update the note accordingly.

#### FISCAL DESCRIPTION

This bill establishes the "21st Century Missouri Education Task Force". The membership of the

### FISCAL DESCRIPTION (continued)

task force includes: three members of the House of Representatives with two members appointed by the Speaker and one appointed by the Minority Leader, three members of the Senate with two appointed by the President Pro Tem and one appointed by the Minority Leader, the Governor or his designee, nine members as appointed by the Governor representing various interested parties, the Commissioner of Education and the Commissioner of Higher Education or their designees.

The mission of the task force is outlined in the bill and includes, but is not limited to, evaluation of current educational process and funding. The task force will make recommendations for legislation as well as submit a report outlining a summary of task force activities to the General Assembly before August 28, 2021.

The task force will suspend operations on January 1, 2022 and reconvene January 1, 2023 to provide updates and review recommendations to be presented by August 28, 2023.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
