### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Elementary and Secondary Education** assume this proposal has no direct fiscal impact on their agency.

In response to the very similar previous version of this bill, the **Department of Higher Education and Workforce Development** assumed this proposal has no direct fiscal impact on their agency.

In response to the very similar previous version of this bill, the **Department of Public Safety-Missouri State Highway Patrol** assumed this bill has no fiscal impact on that agency.

The **Wellsville-Middletown R-I School District** assumes this bill has a negligible fiscal impact on that district.

In response to the very similar previous version of this bill, the **Dent-Phelps R-III School District** assumed this proposal would be helpful in shortage content areas.

In response to the very similar previous version of this bill, the **Shell Knob School District** assumed this bill would not have a significant fiscal impact.

In response to the very similar previous version of this bill, Officials from the **Secretary of State** assumed many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The Secretary of State's office is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to Secretary of State's office for Administrative Rules is less than \$5,000. The Secretary of State's office recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, we also recognize that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what our office can sustain with our core budget. Therefore, we reserve the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

In response to the very similar previous version of this bill, Officials from the **Joint Committee on Administrative Rules** assumed the legislation as amended is not anticipated to cause a fiscal impact to the Joint Committee on Administrative Rules beyond its current appropriation.

#### FISCAL DESCRIPTION

This bill specifies and expands the criteria for qualified applicants desiring to be issued a visiting scholars certificate for those employed as part of an initiative designed to fill vacant positions in hard-to-staff public schools or hard-to-fill subject areas.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
