FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Governor** and **Legislative Research** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Missouri House of Representatives** assume no fiscal impact. The House will absorb any reasonable costs incurred by their members serving on the task force.

Officials from the **Missouri Senate (SEN)** state they anticipate a negative fiscal impact to reimburse 2 members for travel to task force meetings. For two senators, for five meetings, SEN estimates a mileage reimbursement of \$1,184.

Officials from the **Department of Economic Development (DED)** state based upon the current language, the committee will have nine members plus a staff person to facilitate for a total of 10 official participants. Also, the bill requires five meetings to be held in specific cities across Missouri, which will require mileage, per diem, and hotel reimbursement as well.

Since all of these members are subject to appointment by House and Senate leadership, as well as the Governor, there is no way of determining where they will be traveling from to attend these meetings. Therefore, the calculations are based on the assumption that there were two members selected from each city with the exception of Columbia (where it is assumed one would be from Columbia and one staff person would be from Jefferson City).

For each of the meeting costs, mileage reimbursement, meals, hotel, and meeting room costs, were taken into account. Cost estimates for each of the meetings are as follows:

Cape Girardeau meeting:	\$ 4,650
Columbia meeting:	\$ 4,380
Kansas City meeting:	\$ 5,000
St. Louis meeting:	\$ 2,860
Springfield meeting:	\$ 4,430
Total meeting costs:	\$21,320

The department would also need 0.5 FTE to administer the program (for a cost of \$40,600 per year plus expenses and equipment). The total estimated fiscal impact for FY21 is \$59,030.

ASSUMPTION (continued)

Oversight notes this proposal does not have an emergency clause (even though it states the meetings shall be completed by August 1, 2020); therefore, the task force shall, between August 28, 2020 and September 8, 2020, meet five times (once each in Cape Girardeau, Columbia, Kansas City, Springfield, and St. Louis) and compile a full report of its findings and recommendations for legislation for submission to the general assembly. The task force shall terminate on December 31, 2020.

Oversight will assume DED's estimate for meeting expenses includes reimbursement for all members of the task force and will reflect DED's estimate in FY 2021. However, Oversight will assume DED will provide staffing for the task force with existing resources.

The task force will compile a full report of its findings and commendations for legislation and submission to the General Assembly by September 8, 2020, and the task force will terminate on December 31, 2020.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
