FISCAL ANALYSIS

ASSUMPTION

§192.2000 - Minimum dementia-related training requirements

Officials from the **Department of Health and Senior Services (DHSS)** did not respond to **Oversight's** request for a statement of fiscal impact. Based on conversations with DHSS officials, Oversight assumes, for fiscal note purposes, this proposal will have an (Unknown) fiscal impact on the General Revenue Fund.

Oversight notes the **Department of Social Services** has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for this organization.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, nursing homes were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

FISCAL IMPACT - Small Business

This proposal may have a negative fiscal impact on small businesses required to provide employees with additional dementia-related training. (§192.2000)

FISCAL DESCRIPTION

Currently, the Department of Health and Senior Services is required to maintain minimum training requirements for persons involved in the delivery of care to persons with dementia. This bill requires that the department develop those standards in coordination with the Alzheimer's Association, and that it include certain types of initial and ongoing training for administrative employees and those delivering care.

The bill also requires the department to determine how often continuing education will be required and that the department provide oversight of the entities providing training. Finally, it requires the department to ensure that facilities are meeting training requirements and that persons who receive training are demonstrating the required proficiencies. (§192.2000)

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
