#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Office of the Secretary of State** assume the proposal will have no fiscal impact on their organization.

Officials from the Jackson County Election Board, Kansas City Election Board, St. Louis County Board of Elections, and Platte County Board of Elections each assume the proposal will have no fiscal impact on their organization.

**Oversight** notes that the proposal changes the filing fee from \$200 to \$500 for candidates for statewide office or United States senator; from \$100 to \$300 for candidates for representative in Congress, circuit judge, or state senator; and from \$50 to \$150 for candidates for state representative. The proposal also changes the filing fee from \$1000 to \$5000 for candidates for president to be on the presidential primary ballot. All filing fees that are collected are retained by the respective political parties. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.
