AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to special license plates for the United States Coast Guard Auxiliary.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto one new section, to be 2 known as section 301.3063, to read as follows:

301.3063. 1. Any person who is a member of the United States Coast Guard Auxiliary may, after an annual payment of an emblem-use authorization fee to the United 2 3 States Coast Guard Auxiliary as provided under subsection 2 of this section, apply for United States Coast Guard Auxiliary license plates for any motor vehicle such person 4 owns, either solely or jointly, for issuance either for a passenger motor vehicle subject to 5 the registration fees as provided under section 301.055 or for a local or nonlocal 6 property-carrying commercial motor vehicle licensed for a gross weight not in excess of 7 twenty-four thousand pounds as provided under section 301.057 or 301.058. The United 8 9 States Coast Guard Auxiliary hereby authorizes the use of its official emblem to be affixed 10 on multiyear personalized license plates as provided under this section.

11 2. Upon annual application and payment of a fifteen-dollar emblem-use 12 contribution to the United States Coast Guard Auxiliary, the United States Coast Guard 13 Auxiliary shall issue to the person, without further charge, an emblem-use authorization 14 statement, which shall be presented by the member to the department of revenue at the 15 time of registration of a motor vehicle. Upon presentation of the annual statement and 16 payment of the fee required for personalized license plates under section 301.144 and other 17 fees and documents which may be required by law, the department of revenue shall issue

a personalized license plate, which shall bear the emblem of the United States Coast Guard 18 19 Auxiliary in the left-hand section of such license plate and the words "U.S. COAST 20 GUARD AUXILIARY", to the person. The emblem, seal, or logo shall be reproduced on 21 the license plate in as a clear and defined manner as possible. If the emblem, seal, or logo 22 is unacceptable to the United States Coast Guard Auxiliary, it shall be the United States 23 Coast Guard Auxiliary's responsibility to furnish the artwork in a digitalized format. Such 24 license plates shall be made with fully reflective material with a common color scheme and 25 design, shall be clearly visible at night, and shall be aesthetically attractive, as prescribed 26 by section 301.130.

27 3. A fee for the issuance of personalized license plates under section 301.144 shall 28 not be required for plates issued pursuant to this section. There shall be no limit on the 29 number of license plates any person qualified pursuant to this section may obtain so long 30 as each set of plates issued pursuant to this section is issued for vehicles owned solely or 31 jointly by such person. License plates issued pursuant to this section shall not be 32 transferable to any other person except that any registered co-owner of the motor vehicle 33 may operate the motor vehicle for the duration of the year licensed in the event of the death 34 of the qualified person.
